Proclamation No. 109/2006

Proclamation to Decide upon the Elongation Period of the Election of Councils of Districts and Kebeles

WHEREAS, election of district and 'Kebele' Councils shall be held every five years in accordance with the provisions of the Revised Constitution of Oromia National Regional State Articles 82(3) and 94(3) as amended, and as it deems necessary, the 'Caffee' has the power to elongate the period when no convenient condition exists ;

WHEREAS, problems encountered with the previous election have taken extensive time from the start to the end, and have put pressure on development works, and at the time due to these constraints in our Region, it is not expected to undertake democratic and participatory election;

WHEREAS, election undertaken in favorable and conducive environment shall be crucial to the viability of democratic system and community participation;

HEREBY, THEREFORE, in accordance
with article 49(3) (a) of the Revised
Constitution of the National Regional State
of Oromia, proclaimed as follow:

1. Short Title

This proclamation may be cited as "A
Proclamation to Decide on the
Elongation Period of the Election of
Councils of District and Kebele, No.
109/2006."

2. Period to Undertake Election of the Councils

- 1) Without prejudice to the period of
election of the woredas Councils that
undertaken every five years,
'Caffee' can extend for a period of
not more than one year, where
unfavorable condition exists;
- 2) Rights and duties, as well as, roles
of different organs shall remain in
force as per allowed by the Revised
Constitution of the National Regional
State and other pertinent laws,
where period of election elongated;
- 3) Election of Councils of Kebeles shall
be undertaken as per enshrined
under sub articles (1) and (2) of this
article.

3. Not notwithstanding the provisions under
article 2 of this proclamation, where
period of Election extended, the existing
Councils and Government Organs shall
remain in force until election
concluded and newly elected Councils
established.

4. Effective Date

This Proclamation shall come into effect
as of the 24th day of March, 2006.
