Proclamation No. 110 of 2006

A Proclamation to Amend the
Proclamations for the Reorganization
and Redefinition of the Powers and
Duties of Executive Organs of Oromia
No. 87/2004 and No. 105/2005

WHEREAS, it has become necessary to
transfer the powers and duties of Oromia
Design and Construction Authority to
Oromia Works and Urban Development
Bureau;

WHEREAS, it is necessary to revoke the
powers and duties of Oromia Works and
Urban Development Bureau to study and
prepare plans and Topography of cites;

NOW, THEREFORE, in accordance with
Art 49(3) (a) of the Revised Constitution
of the Oromia National Regional State, it is
hereby proclaimed as follows.

1. Short Title

This Proclamation may be cited as
“Proclamation No. 110 of 2006 Issued to
Amend Proclamations No. 87 of 2004
and No. 105 of 2005, the Reorganization
and Redefinition of the Powers and Duties
of the Executive Organs of Oromia
National Regional State.”

2. Fooyya'iinsa

2. Amendment

Proclamation No. 87 of 2004 and No.105 of 2005 are amended as follows:

“1) The Oromia Design and Construction Authority established under Proclamation No. 87 of 2005 is hereby dissolved by this proclamation.

2) Without prejudice to the power and duties to implement urban plans, the other powers and duties given under proclamation No.105 of 2005 Article 9(4) to Oromia Works and Urban Development Bureau are hereby repealed and transferred to the Institution to be established by the Regulation issued by the Administrative Council of the Regional Government.

3) Without prejudice to the amendment made above under Article 2 (2) and, powers and duties given by Proclamation N° 105 of 2005 to Oromia Works and Urban Development Bureau, Article 26 Sub Article 1-10 of the Proclamation No. 87 of 2004 are repealed and re-enacted as follows and transferred to the powers and duties of Oromia Works and Urban Development Bureau.

(a) Prepare codes and standards for the building constructions of the region; approve qualities of building projects within the region, are prepared and executed in accordance with the codes and standards;

(b) Ensure and approve that the design of private or investment construction projects in the region are executed in accordance with the codes and standards; issue construction license, or delegate other organs to issue;

(c) Prepare Design and Contract Agreement for the projects undertaken by the government budget;

- (g) Bakka barbaachisaadha jedhee itti amane hundatti Biirron Hojiifi Misooma Magaalaa hojiiwwan ijaarsa gamoowwanii ilaalchisee sadarkaa caalbaasii, sadarkaa ijaarsaafi sadarkaa wal harkaa fuudhiinsaatti inispekshinii ni gaggeessa; tarkaanfii sirreeffamaas ni fudhata;
- (h) Meeshaa ijaarsaa naannootti argamuun gamoowwan akka ijaaramaniifi gatiin pirojektoota gamoowwanii akka gadi bu'u qorannoofi istaandaardii adda addaa qopheessee Naannicha keessatti akka hojiirra oolu ni taasisa;
- (i) Gatii yeroo, meeshaa ijaarsaafi humna namaa qindeessuun, sektaroota akka beekan ni godha.
- (j) Naannicha keessatti hojii ijaarsaa irratti hirmaachuudhaaf gaaffiin heyyama kontiraaktarummaa yoo dhiyaate gamaaggamuudhaan heyyama sirrii ta'e akka argatan ni taasisa; heyyama ni haaroomsa; ni galmeessa; haala raawwiisaanii irratti hundaa'uun kontraaktaroota gareen addaan baasee waajjiraleen sektaroonni akka beekan ni godha;

- ሰ) የሥራና ከተማ ልማት ቢሮ አስፈላጊ ነው ብሎ ባመነበት ቦታ ሁለ የሕንፃ ግንባታን በተመለከተ በጨረታ፣ በግንባታና በርክክብ ደረጃ ላይ ኢንስፔክሽን ያካሄዳል፤ የማስተካከያ እርምጃም ይወስዳል፤
- ሸ) ሕንፃዎች በአንባቢው በሚገኙ የግንባታ ማቴሪያሎች እንዲገነቡና የሕንፃ ግንባታ ፕሮጀክቶች ዋጋ ዝቅ እንዲል ጥናትና የተለያዩ እስታንደርዶችን በማዘጋጀት በክልሉ በሥራ ላይ እንዲውሉ ያደርጋል፤
- ቀ) የወቅቱ ዋጋ፣ የግንባታ የማቴሪያል የሰው ኃይል በማቀናጀት የሴክተር መ/ቤቶች እንዲያውቁ ያደርጋል፤
- በ) በክልሉ ውስጥ በኮንስትራክሽን ዘርፍ ለመስማራት ለሚፈልጉ ኮንትራክተሮች የፈቃድ ጥያቄአቸውን በመገምገም ትክክለኛ ፈቃድ እንዲያገኙ ያደርጋል፤ ፈቃድ ያደሳል፤ ይመዘግባል፤ በሥራ አፈፃፀማቸው ላይ በመመስረት ኮንትራክተሮችን በቡድን በመለየት የሴክተር መ/ቤቶች እንዲያውቁ ያደርጋል፤

- (d) Evaluate and approve construction bid documents and bid evaluation, or delegate other body;
- (e) Evaluate and make decision upon questions of variation order, additional construction work and price change, or delegate other body;
- (f) Undertake inspection evaluate performance of projects building constructions in the region; find solutions for the problems encountered and suggest solutions and corrective measures to the government; the manner of inspection shall be explained by the regulation to be issued by the Administrative Council of the Regional Government and directives of the Bureau;
- (g) Where ever deemed necessary, the Works and Urban Development Bureau shall inspect and take corrective measures as regards building construction at the level of bid, at the level of construction and handover of project and take appropriate remedial actions;
- (h) Study and prepare various standards and cause its implementation in the region in order to contract buildings with local construction materials and lower cost of building projects;
- (i) Prepare the current cost, construction materials and man power, and communicate to the sectoral offices;
- (j) Issue construction licenses to contractors upon evaluating their requests; renew, register and grade them depending upon their performance and inform their status to the sectoral Bureaus;

(k) Sadarkaa dizaayinii, bulchiinsa kontraataa, ijaarsaafi gatii piroojektoota gamoowwanii akka qophaa'uu ni taasissa; qopha'ee yoo dhiyaate ni mirkaneessa; dhimmota kana ilaalchisee Mootummaaf gorsa ni kenna;

(l) Gaaffii heeyyama ogummaa piroofeeshinaalotaa ni kenna; heeyyama gorsitootaa gamaaggamee heyama sirrii ta'e akka argatan ni taasisa;

(m) Daandiiwwan magaalota keesatti hojjatamaniif hojii dizaayiniifi ijaarsa isaanii gamaaggamuudhaan sirriitti raawwatamu isaa ni mirkaneessa;

(n) Seektera dizaayiniifi konistraakshinii ilaalchisee hojii Mootummaan itti kennu ni raawwata; gabaasa ni dhiyeessa.

(k) Cause the standards for the building design, contract Administration, prices for building and projects, be prepared, approve those prepared and submitted; and advise the government regarding construction issues;

(l) Issue licenses of Professionals, and consultancy services licenses upon evaluating and checking their requests.

(m) Evaluate and ensure the standard of designs and construction of roads undertaken in the cities/ urban.

(n) Execute activities given to it by the government regarding Design and Construction sector and produce the report.

3. Effective Date

This Proclamation shall come in to force as of the 24th day of March, 2006.
