WHEREAS, it is decisive to form and determine the powers of the organs of the Commission phase by phase;

NOW, THEREFORE, in accordance with Article 49(3)(a) of the Revised Constitution of the Oromia Regional State, it is hereby proclaimed as follows:

Part One

General Provisions

1. Short Title

This Proclamation may be cited as "The Oromia Regional State Investment Administration Re-establishment Proclamation No. 115 of 2006."

2. Definitions

Unless the context requires otherwise, in this Proclamation:

- 1) "Caffee" means the Council of Regional State of Oromia.
- 2) "Regional Administrative Council" means a higher executive organ of the Region.
- 3) "Administrative Council" means executive organs organized at zone, 'Aanaa' and 'Gandaa' levels.
- 4) "Board" means Investment Board of Oromia National Regional State.
- 5) "Commission" means Investor Commission of Oromia.
- 6) "Rural land" means land outside urban delineated area or not delineated under urban master plan or not approved by the appropriate organ to be delineated under urban master plan or not approved to be administered by lease as urban land.
- 7) "Urban land" means land held under urban master plan or land not delineated under urban master plan; however, it is decided by appropriate organ to be delineated under urban land.
- 8) "Domestic Investor" means an investor who is Ethiopian by birth or nationality.

- 9) “Abbaa qabeenyaa biyya alaa” jechuun investara dhaloonniifi lammummaan isaa Itiyoophiyaadhaan ala ta’e jechuudha.
- 10) “Abbaa qabeenyaa dhalootaan Itiyoophiyaa ta’e” jechuun investara dhaloonni isaa Itiyoophiyaa ta’ee lammummaan isaa kan biyya alaa ta’e jechuudha.
- 11) “Investimentii babal’isaa ykn fooyya’iinsaa” jechuun dandeettii omishaa ykn tajaajila kennuu dhaabbatichaa dhibbeentaa digdamii shanii (%25) oliin humna namaafi kaappitaalaan ol guddisuu jechuudha.
- 12) “Kaappitaala” jechuun maallaqa biyya keessaa ykn biyya alaa, sanadoota daddabaraa, meeshaalee omishaa ykn kenna tajaajilaa ittiin kennan, gamoo, baajata hojii adeemsiftuu ka’umsaa; akkasumas mirga qabiyyee jechuudha.
- 13) “Labsii Investimentii” jechuun Labsii Investimentii Mootummaa Federaalaa Lak. 280/1994 (akka fooyya’ettii) jechuudha.
- 14) “Lafa Misooma” jechuun lafa hojii misooma qonnaatiif tajaajila kennaa ture ta’ee, erga tajaajilicha kennuu dhaabe waggaa shan kan hin caaliniifi haala salphaadhaan deebi’ee misoomuu kan danda’u jechuudha.
- 15) “Naannoo” jechuun Naannoo Oromiyaati.
- 16) “Nama” jechuun nama uumamaa ykn dhaabbata seeraan qaama namummaa argate kamiyyuu jechuudha.

3. Daangaa Raawwatiinsaa

Aangoon Labsii kanaan kenname hojiiwwan Investimentii barbaacha, qorannoofi Omisha albuudaafi boba’aa irratti raawwatiinsa hin qabaatu.

4. Hundeeffama

Bulchiinsi Investimentii Oromiyaa ammaan booda “Bulchiinsa Investimentii” jedhamee kan waamamu Labsii kanaan irra deebi’amee hundeeffameera.

፲፫) “የኢንቨስትመንት አዋጅ” ማለት የፌዴራል መንግሥት ኢንቨስትመንት አዋጅ ቁጥር ፪፻፳/፲፱፻፲፱ /እንደተሻሻለው/ ማለት ነው።

፲፬) “የለማ መሬት” ማለት ለአርሻ ልማት ሥራ አገልግሎት ሊሰጥ የነበረና በማንኛውም ምክንያት ያደረ መሬት ሆኖ መሬት ሆኖ አገልግሎት መስጠቱን ካቆመ ከአምስት ዓመት ያልበለጠና በቀላሉ መልሶ ሊለማ የሚችል መሬት ማለት ነው።

፲፭) “ክልል” ማለት የኦሮሚያ ክልል ማለት ነው።

፲፮) “ሰው” ማለት የተፈጥሮ ሰው ወይም ሕጋዊ ሰውነት ያገኘ ማንኛውም ድርጅት ማለት ነው።

፫. የተፈጻሚነት ወሰን

በዚህ አዋጅ የተሰጠው ሥልጣን በማዕድንና ነዳጅ ፍለጋና የማምረት ሥራዎች ላይ ተፈጻሚነት አይኖረውም።

፬. ስለመቋቋም

የኦሮሚያ ኢንቨስትመንት አስተዳደር ከዚህ በኋላ “የኢንቨስትመንት አስተዳደር” ተብሎ የሚጠራ በዚህ አዋጅ እንደገና ተቋቁሟል።

9) “Foreign Investor” means an investor who is foreign both by birth and nationality.

10) “Foreign National Investor” means an investor who is born in Ethiopia, however, who acquires a foreign nationality.

11) “Expansion or upgrading Investment” means increasing the production or service rendering capacity of the enterprise in human power and capital by more than 25%.

12) “Capital” means local or foreign currency, negotiable instruments, machinery or equipment, building, initial working capital as well as property rights.

13) “Investment Proclamation” means the Federal Government Investment Proclamation No. 280 of 2002 (as amended).

14) “Developed land” means the land that had been used for agricultural development and left fallow for not more than five years as well as which can be easily developed again.

15) “Region” means Oromia Region.

16) “Person” means natural person or an organization that acquired legal personality.

3. Scope of Application

The provisions of this Proclamation shall not be applicable to investments in the exploration and development of minerals and petroleum resources.

4. Establishment

The Oromia Investment Administration hereinafter referred to as “Investment Administration” is hereby re-established.

5. Kaayyoo

5. Objectives

In addition to the objectives stated under Article 4 of the Investment Proclamation, the Investment Administration shall have the following objectives:

- 1) To expand social services and economic developments in the Region,
- 2) To strengthen sustainable growth or development in the Region;
- 3) To help and encourage people of the Region, particularly, the Peasants/pastoralists to use modern technology and investment output;
- 4) To strengthen lasting progress and development by legally making use of resources of the Region;
- 5) To facilitate means of engaging peasants whose land was taken over in development endeavors by reorganizing them.

Part Two**Organs of Investment Administration****6. Organization**

The Investment Administration of the Region shall have the following organs:

- 1) Investment Board;
- 2) Investment Commission;
- 3) Investment Committee of the Zone,
- 4) Investment Committee of the 'Aanaa'; and
- 5) Investment Committee of the urban administration.

7. Investment Board

- 1) The Board shall be accountable to the President of the Region.
- 2) Board members composed of seven to nine shall be selected from appropriate organs and appointed by the President of the Region.

8. Meeting of the Board

- 1) The Board shall meet regularly once every month; however, it may hold extraordinary meeting when necessary.

9. Aangoofi Hojii Boordii Investmentii

Investimentii ilaalchisee yaada imaammataa ni burqisiisa; murteedhaaf Mana Marii Bulchiinsa Mootummaa Naannichaatiif ni dhiyeessa.

3) Raawwii seerota investimantii ol'aantummaadhan ni too'ata ykn ni hordofa.

9. Powers and Duties of the Board

The Board shall:

1) Generate policy ideas with respect to investment; submit the proposal for approval by the Regional Council.

2) Issue directives necessary for promotion of investment in the Region.

3) Control the implementation of investment laws as a superior authority.

4) Give final decision on appeals based on law or fact filed by investors except litigation on claims of inadequate compensation or denial of compensation or claim that contains fundamental error of law.

5) Exert effort to broaden good relations between government organizations, non-governmental organizations, investors and the like by creating various forums that help facilitate conducive environment for swift investment activities.

6) Give decision on policy issues arising in connection with investment laws.

7) Submit necessary amendments to be made on regulations concerning investment incentives, to the Regional Council for approval.

8) Determine service fees or charges to be collected by the Commission from customers.

10. Powers and Duties of Investment Commission

The Investment Commission shall:

- 1) Issue, renew or cancel investment permits, in accordance with investment Proclamation and regulations, concerning investment requests which do not fall within the power of the Ethiopian Investment Agency.
- 2) With respect to investors holding investment permits:
 - (a) Issue business license;
 - (b) Conduct registration of business license;
 - (c) Register, where necessary, memorandum of associations of business organizations by representing the appropriate organs;
 - (d) Sign contracts of investment land decided by the Board and the Commission itself; administer and monitor investment activities; details shall be specified in the regulations;
 - (e) Unless the investors begin or complete their work or begin production or service provision based on the laws and their contracts, cancel their contracts and take back the land rented to them.
- 3) Where the legal requirements are fulfilled, give land holding certificates concerning the land to be granted by the Board and/or itself in accordance with sub Article 2 of this Article, when the required information is fully presented, provide construction permits based on construction design approved by the appropriate organ.

- 7) Monitor investors who got construction permits that they conduct their activities within the time limit stated in their contracts; give rectification directives; takes also legal action.
- 8) Collect, organize and disseminate information on investment land prepared and not prepared.
- 9) Give decision on granting of investment land; evaluate the legality of contracts signed by investment committees; if error is found, issue corrective directives; ascertain the correction of same.
- 10) Measure and enclose investment land; prepare and give site plan, to the leasee where necessary.
- 11) Prepare and conduct meeting, training and seminar that help encourage and promote investment activities where necessary; give consultancy assistance to investors, writes letters of cooperation.
- 12) Give decisions, in collaboration with the Ethiopian Investment Agency, on land request made by foreign investors and foreign nationals of Ethiopian origin who intend to work jointly with domestic investors conclude contracts, follow-up its implementation, cancel contracts.

14) Study and keep reliable information concerning investment sectors that should be conducted in the Region and disseminate same.

15) Organize, train, follow up, evaluate and supervise the structures of the Commission and Zone, 'Aanaa' and urban investment administration organs at each level.

16) Prepare and disseminate various illustrative articles.

17) Devise ways in which electricity, telephone and water problems are solved in consultation with appropriate organs.

18) Study objective conditions of the market, consult with appropriate body on expansion of market service, and dispatch information.

11. Investment Committees

1) Investment Committees hereinafter referred as to, "Zone Investment Committee", "Aanaa Investment Committee", "Urban Administration Investment Committee" are hereby established by this Proclamation.

2) The Zone Investment Committee shall be accountable to the Board.

3) The 'Aanaa' Investment Committee shall be accountable to Zone Investment Committee.

4) Investment Committees of first and second grade urban administrations shall accountable to the Board; whereas, investment committees of third and fourth grades townships and investment committees of other towns shall be accountable to the 'Aanaa' Investment Committee.

The Committee:

- 1) Inspects that investment underway in the 'Aanaa' is being conducted in accordance with investment Proclamation, regulations and directives of the Region; gives consultancy services to investors; issues directives to solve problems with out obstructing the activities of investors.
- 2) Identifies and keeps the types of investment that should be conducted in the 'Aanaa' and the area where it should be conducted in consultation with the appropriate organs; identifies and registers land to be used for investment; delineates their boundaries; facilitates conditions for the livelihood of peasants and pastoralists moved from the land; communicates its performance to the Commission and zone investment committee; makes copy to investment office of the zone.
- 3) Collects and organizes information on investment alternatives/potentials of the 'Aanaa' and presents to the investment Committee of the zone and the Commission.
- 4) Implements, observes and causes observation of the decisions of the Board, the Commission and zone Investment Committee.
- 5) Based on power vested to it by the law, passes decision on land requested by domestic investors only; concludes contract; monitors its implementation; where necessary, cancels the contract; its implementations modalities shall be specified in the regulations.
- 6) Provides certificate of possession of the land to the lessee.
- 7) Administers, leads, and supervises investment activities of the 'Aanaa' as a superior body.

 - (g) Head of Public Health Office.....Member.
 - 2) In the third and fourth grades townships as well as in towns that do not have municipality, the 'Aanaa' council shall establish the committee jointly with 'Gandaas' in the town; chairperson and secretary of the committee shall be elected by majority vote from among its members.

18. Powers and Duties of Urban Investment Committee

The Urban Investment Committee:

- 1) Inspects and follows up that investment activities of the town is underway in accordance with investment proclamation, regulations and directives of the Region, issues directives to correct mistakes committed without obstructing investment activities; provides consultancy services to investors.
- 2) Identifies the types of investments that should be under taken in the town in consultation with the appropriate organ; keeps concrete information; sends same to its superior.
- 3) Studies and prepares places on which investment should be conducted; clears them from claims; encloses them; determines its standard in accordance with master plan of the town; based on the standard, approves the project that should be undertaken; sends same to its superior.
- 4) Concludes contract with investors who have interest to do investment in the town based on power vested to it; administers the investment; follows-up its implementation; issues corrective directives; cancels contracts in accordance with laws and directives.
- 5) Provides the certificates of possession of land, site plan and construction permit to the lessee.
- 6) Sends information concerning performance report and land prepared every month to its superior.
- 7) Observes, causes observance and implements the decisions of the Board, the Commission and those passed by appropriate organ.
- 8) Performs any function assigned to it by the appropriate organ.

19. Meetings of 'Aanaa' Investment Committee and Urban Administration Investment Committee

- 1) The 'Aanaa' Investment Committee and Urban Administration Investment Committee shall meet regularly once every ten days; however, the committee may hold extraordinary meeting when necessary.
- 2) The meeting shall be conducted when more than half of the members of the Committee are present.
- 3) Decisions of the Committee shall be passed by majority vote; however, the chairperson shall have casting vote in case of a tie.
- 4) Without prejudice to the provisions of this Article, the committee may draw up its own rules of procedure
- 5) Based on the necessity of the case, the committee may invite to its meetings various professionals, receives professional opinion and in accordance with the contract concluded, it may cause the preparation of certain documents.

Part Three**Miscellaneous Provisions****20. Duty to Cooperate**

- 1) Any concerned person shall be obliged to cooperate in matters concerning the implementation of this Proclamation.
- 2) Any concerned executive body of the Regional State shall have the obligation to provide or send when requested information concerning investment.

21. Inapplicable laws

- 1) The Oromia Investment Administration Proclamation No. 2/ 1995 (as amended) is hereby repealed.

22. Transitory Provisions

Activities started in accordance with the previous laws and directives shall continue in accordance with the provisions of this Proclamation.

23. Power to Issue Regulations and Directives

- 1) The Regional Council of State shall have a power to issue regulations for the proper implementation of this Proclamation.
- 2) The Investment Board may issue directives to implement the regulations issued in accordance with this Proclamation.

24. Effective Date

This Proclamation shall come into force as of 12th day of July, 2006.
