Short Title This Proclamation may be cited as “Proclamation No.116 of 2006 Issued to Amend Proclamation No.65 of 2003, the Urban Local Government Proclamation of Oromia National Regional State.”

1. Mata Duree Gabaabaa
 Labsiin kun “ Labsii Bulchiinsa Naannoo Magaalaa Mootummaa Naannoo Oromiyaa Lak. 65/1995 Fooyyessuuf Bahe Lak. 116/1998” jedhamee waamamuu ni danda'a.

2. Fooya'iinsa

- 1) Keewwanni 2(2) jalatti jechi “Bulchiinsa Naannoo Magaalaa” jedhu haqamee jecha “Bulchiinsa Magaalaa “ jedhuun bakka bu’eera.
- 2) Keewwanni 2(3) haqamee akka kanatti aanutti fooyya’eera: “Mana Maree” jechuun akka magaalaa Sadarkaa 1^{ffaa} fi 2^{ffaa} tti Mana Maree Magaalaa jechuu yoo ta’u; akka magaalaa sadarkaa 3^{ffaa} fi 4^{ffaa} irra jiranuutti immoo Mana Maree Aanaa akkaataa Heera Fooyya’aa Mootummaa Naannoo Oromiyaa keewata 77 Keewwata Xiqqaa 2(a) tin dhaabbate, akkasumas Mana Maree Gandaa Magaalaa keessatti dhaabbate kan dabalatuudha.”
- 3) Keewwanni 2(9) haqamee kan kanatti aanuun bakka bu’eera. “Biiroo” jechuun Biiroo Hojii fi Misooma Magaalaa Oromiyaa jechuudha.”
- 4) Keewwanni 13(3) haqamee kan kanatti aanuun bakka bu’eera: “Magaalaa sadarkaa 1^{ffaa} fi 2^{ffaa} keessatti baay’inni jiraattota Oromoo muraasa ykn gad-aanaa ta’ee yoo argame Manni Maree Bulchiinsa Mootummaa Naanichaa baay’ina uummata Oromoo baay’ina ummata biroo wajjin wal bira qabee ilaaluun barcuma Mana Maree Magaalichaa keessaa %50 akka eegamuuf taasisuu ni danda’a. Tumaan kun kan Mana Maree Gandaa irrattis raawwattiinsa ni qabaata.”
- 5) Keewwanni 13(4) haqamee kan kanatti aanun bakka bu’eera. “Mana maree Magaala sadarkaa 1^{ffaa} fi 2^{ffaa} keessatti Ganda/Gandoota baadiyyaa bulchiinsa magaalichaa daangessaniif barcuma Mana Maree Magaalichaa keessaa %20 ni eegamaaf. Bakka bu’oonni Ganda/Gandoota baadiyyaa magaalicha daangessanis filatamtoota keessaa Mana Maree Gandaa /Gandootaatiin bakka bu’u.”

««ምክር ቤት» ማለት እንደ ፩ኛ እና ፪ኛ ደረጃ ከተሞች የከተማ ምክር ቤት ማለት ሲሆን በ፫ኛ እና ፬ኛ ደረጃ ላይ እንደሚገኙ ከተሞች ደግሞ የተለየ ምክር ቤት ሳያስፈልግ ገጠርና ከተሞችን አጣምሮ በኦሮሚያ ብሔራዊ ክልላዊ መንግስት ህገ መንግሥት አንቀጽ ፳፯ ንዑስ አንቀጽ ፪ (ሀ) መሰረት የተቋቋመ የወረዳ ምክር ቤት፣ እንዲሁም በከተማ የተቋቋመ የቀበሌ ምክር ቤትን የሚጨምር ነው።»

- ፬) አንቀጽ ፲፫ (፫) ተሰርዞ በሚከተለው ተተክቷል። «በ፩ኛ እና ፪ኛ ደረጃ ከተማ ውስጥ ኦሮሞ የሆኑ ነዋሪዎች ቁጥር ጥቂት (ዝቅተኛ) ሆኖ ከተገኘ የክልል መስተዳደር ምክር ቤት የኦሮሞን ህዝብ ቁጥር ከሌሎች ህዝቦች ቁጥር ጎን ለጎን በማስተያየት ከከተማው ምክር ቤት መቀመጫ ውስጥ ፶% ለኦሮሞዎች እንዲጠበቅ ሊያደርግ ይችላል። ይህ ድንጋጌ በቀበሌ ምክር ቤትም ላይ ተፈጻሚነት ይኖረዋል።»
- ፭) አንቀጽ ፲፫ (፬) ተሰርዞ በሚከተለው ተተክቷል።
«በ፩ኛ እና በ፪ኛ ደረጃ ከተማ ምክር ቤት ውስጥ ከተማውን ለሚያዋስኑ የገጠር ቀበሌ ወይም ቀበሌዎች ከከተማው ምክር ቤት መቀመጫ ውስጥ ፳% ይጠበቅላቸዋል።

2. Amendment

- 1) The statement that reads “Urban Local Government” under Article 2(2) is repealed and replaced by statement that reads as “Urban Administration.”
- 2) Article 2(3) is repealed and amended as follows:
“City council” Means, as it applies to 1st and 2nd grade city it is a city council; whereas to the city of 3rd and 4th grade, without the need for separate council it includes ‘Aanaa’ council consisting of the rural and the city established in accordance with Art. 77 sub article 2(a) of the Revised Constitution of the Oromia National Regional State and as well as the council of city ‘Gandaa’.”
- 3) Article 2(9) is repealed and replaced by the following:
“Bureau’ means Oromia Works and Urban Development Bureau.”
- 4) Article 13(3) is repealed and replaced by the following:
“When the number of Oromo residents in 1st and 2nd grade city is found minor or undersized, the administrative council of the National Regional Government may notice the number of Oromo People against other people and reserve 50% of the seats in the city council. This provision is also applicable to the council of the city ‘Ganda.’
- 5) Article 13(4) is repealed and replaced by the following :
“In the 1st and 2nd grade city, 20% shall be reserved from the seats in the city council for the hinterland rural ‘Ganda’/’Gandoota’ surrounding the city administration. Representatives of the hinterland are from among the elected members of the council of the ‘ganda’/’gandoota’.”

7) Keewwanni 18 (1) haqamee kan kantatti aanuun bakka bu'eeraa. "Itti waamamni Kantiibaa magaalaa sadarkaa 1^{ffaa} fi 2^{ffaa} Pireezidaantii Bulchiinsa Mootummaa Naannichaatif ta'ee, karooraafi gabaasa isaa Mana Maree Magaalaa sanaaf ni dhiyeessa."

3. Tumaalee Haaraa

1) Magaalaa sadarkaa 3ffaa fi 4ffaa tif Mana Maree addaa dhaabuun utuu hin barbaachisin akka ganda/gandootaatti lakkaa'amuun Mana Maree Aanichaa keessatti hirmaannaa ni qabaatu.

2) Dura Taa'aafi Kaabineen Ganda Magaalaa, Kantiibaa Magaalaatin muudamu.

3) Magaalonna sadarkaa 3ffaa fi 4ffaa Mana Maree mataa isaanii hin qabaatanu.

6) Article 14 (g) and Article 19 (1) are repealed and replaced by the following:

"The mayor and deputy mayor of the 1st and 2nd grade city shall be appointed by the president of the National Regional Government."

7) Art. 18 (1) is repealed and replaced by the following:

"Accountability of the mayor of 1st and 2nd grade city shall be to the President of the National Regional Government. And also produce his plan and report to the council of the city."

3. New provisions

1) Without the need for the establishment of separate council for 3rd and 4th grade city, they shall have representation in the 'Aanaa' council as 'ganda'/'gandoota'.

2) The chairperson and the cabinet of city 'Gandaa' shall be appointed by the mayor of the city.

3) Cities of 3rd and 4th grade shall have no separate council

4. Effective Date

This proclamation shall come to effect as of 12th day of July, 2006.
