Haaluma kanaan, baay'ina miseensota Manneen Maree Aanaa, Gandaafi Magaalaa murteessuufi qophii barbaachisaa ta'e taasisuuf jecha bu'uura Heera Fooyya'aa Mootummaa Naannoo Oromiyaa kan bara 1994 bahe Keewwata 49(3)(a) tiin kan kanatti aanu labsameera.

**1. Mata Duree Gabaabaa**

Labsiin kun "Labsii Filannoo Miseensota Manneen Maree Aanaa, Gandaafi Bulchiinsa Magaalota Murteessuuf Bahe Labsii Lak. 119/1999," jedhamee waamamuu ni danda'a.

**2. Filannoo Miseensota Manneen Maree Aanaa**

- 1) Filannoo miseensota Manneen Maree Aanaa kan gaggeeffamu Gandoota Aanaa sana keessatti argaman bu'uureeffachuun ta'a.
- 2) Miseensi Mana Maree Aanaa tokko jiraattota Gandichaa keessaa filatamee bakka bu'a.
- 3) Baay'inni miseensa Mana Maree Aanaa ganda tokkorraa nama sadi-sadii ta'a.

**3. Filannoo Manneen Maree Ganda**

- 1) Filannoo Miseensota Mana Maree Ganda jiraattota gandicha keessatti argaman bu'uureeffachuun kan gaggeeffamu ta'a.
- 2) Miseensi Mana Maree Ganda tokko jiraattota Gandichaa yoo xinnaate nama 5 yoo guddate nama 100 bakka bu'a.
- 3) Baay'inni miseensota Mana Maree Ganda 100-300 ta'a.
- 4) Keewwata kana Keewwata Xiqqaa 3 irratti kan ibsame yoo jiraateyyuu Gandoota lakkoofsi uummataa xiqqaa ta'e keessatti miseensonni Mana Maree Ganda 100 gadi ykn lakkoofsi uummataa baay'ee ta'e keessatti 300 ol ta'uu ni danda'a.

**4. Filannoo Miseensota Manneen Maree Bulchiinsa Magaalaa**

- 1) Filannoo Mana Maree Bulchiinsa Magaalaa kan gaggeeffamu magaalota sadarkaa 1<sup>ffaa</sup> fi 2<sup>ffaa</sup> qofa keessatti ta'a.
- 2) Magaalota sadarkaa 3<sup>ffaa</sup> fi 4<sup>ffaa</sup> keessatti filannoo gaggeeffamu akka Gandaatti lakkaa'amanii filannoo Mana Maree Aanaa keessatti argaman keessatti hirmaatu.

**፩. አዋጅ ርዕስ**

ይህ አዋጅ "በኦሮሚያ ብሔራዊ ክልላዊ መንግሥት የወረዳ፣ የቀበሌና የከተማ አስተዳደር ምክር ቤት አባላት ምርጫን ለመወሰን የወጣ አዋጅ ቁጥር ፩፻፲፱/፲፱፻፺፱" ተብሎ ሊጠቀስ ይችላል።

**፪. የወረዳ ምክር ቤት አባላት ምርጫ**

- ፩) የወረዳ ምክር ቤት አባላት ምርጫ የሚካሄደው በወረዳው ውስጥ የሚገኙትን ቀበሌዎች መሠረት በማድረግ ይሆናል።
- ፪) አንድ የወረዳ ምክር ቤት አባል የተመረጠበትን የቀበሌውን ነዋሪዎች ይወክላል።
- ፫) ለወረዳ ምክር ቤት አባልነት ከአንዱ ቀበሌ ሦስት ሦስት ሰው ይመረጣል።

**፫. የቀበሌ ምክር ቤት አባላት ምርጫ**

- ፩) የቀበሌ ምክር ቤት አባላት ምርጫ የሚካሄደው የቀበሌውን ነዋሪዎች መሠረት በማድረግ ይሆናል።
- ፪) አንድ የቀበሌ ምክር ቤት አባል ቢያንስ ፩ ቢዛዛ ፻ የሚሆኑ የቀበሌ ነዋሪዎችን ይወክላል።
- ፫) የቀበሌ ምክር ቤት አባላት ብዛት ፻፫ ይሆናል።
- ፬) በዚህ አንቀጽ ንዑስ አንቀጽ ፫ የተደነገገው ቢኖርም አነስተኛ የነዋሪዎች ብዛት ባላቸው ቀበሌዎች የቀበሌ ምክር ቤት አባላት ብዛት ከ፫ በታች ወይም ከፍተኛ የህዝብ ብዛት ባላቸው ቀበሌዎች ከ፫ በላይ ሊሆን ይችላል።

**፬. የከተማ አስተዳደር ምክር ቤት አባላት ምርጫ**

- ፩) የከተማ አስተዳደር ምክር ቤት አባላት ምርጫ የሚካሄደው በአንደኛና በሁለተኛ ደረጃ ከተሞች ብቻ ይሆናል።
- ፪) በሦስተኛና አራተኛ ደረጃ ከተሞች ውስጥ የሚካሄደው ምርጫ እንደ ቀበሌ ተቆጥረው በሚገኙበት ወረዳ የምክር ቤት አባላት ምርጫ ውስጥ ይሳተፋሉ።

NOW, THEREFORE, to determine the number of the Members of Woreda, Kebele and Urban Administration Council and to facilitate the necessary condition for the election in accordance with article 49(3)(a) of the Revised Constitution of Oromia National Regional State it is hereby proclaimed as follow.

**1. Short Title**

This proclamation may be cited as "The Proclamation to Provide for the Election of Member of Woreda, Kebele, and Urban Administration Councils No. 119/2006."

**2. The Election of Members of Woreda Councils**

- 1) The election of members of Woreda Copuncil shall be carried out on the bases of Kebeles found in that Woreda.
- 2) Each Council member shall represent the residents of the Kebele from which he has been elected.
- 3) Three members from each Kebele shall be elected for Woreda Council.

**3. The Election of Kebele Council Members**

- 1) The election of Kebele Council Members shall be carried out on the bases of the Kebele residents.
- 2) Each Kebele Council member shall represent a minimum of 5, or a maximum 100 residents.
- 3) The number of members of Kebele Council shall be from 100 to 300.
- 4) Not withstanding Sub-Article 3 of this Article, the number of members of Kebele Council may be less than 100 where the population is small, or more than 300 where the population is big.

**4. The Election of Urban Administrative Council Members**

- 1) The election of members of Urban Administration Council shall be carried out only in 1st and 2nd Grade Urban Administrations.
- 2) The Election conducted in 3rd and 4th Grade Urban Administration Council shall be considered as the election carried out at Kebele level and participate in the election of members of Woreda Council.

- 3) Filannoon Miseensota Mana Maree Magaalota sadarkaa 1<sup>ffaa</sup> fi 2<sup>ffaa</sup> kan gaggeeffamu jiraattota magaalaa keessatti argaman bu'uureeffachuun ta'a.
- 4) Miseensonni magaalota sadarkaa 3<sup>ffaa</sup> fi 4<sup>ffaa</sup> keessaa Mana Maree Aanaa keessatti argamaniif filataman baay'ina jiraattota magaalaa tilmaama keessa galchuun qoodni gahaan ni kennamaaf.
- 5) Miseensi Mana Maree Bulchiinsa Magaalaa tokko jiraattota magaalaa nama 300 hanga 3000tti bakka bu'a.
- 6) Baay'inni miseensota Manneen Maree Magaalota sadarkaa 1<sup>ffaa</sup> fi 2<sup>ffaa</sup> akkaataa Labsii Lak. 65/1995 Keewwata 13 Keewwata Xiqqaa 2 irratti tumameerraa ka'uun 41 hanga 81 qabaatu.
- 7) Filannoo miseensota Manneen Maree magaalota sadarkaa 1ffaa fi 2ffaa keessatti adeemsifamuuf baay'ina Oromootaafi jiraattoo gandoota baadiyyaa naannoo magaalatti argaman ilaalchisee akkaataa Labsii Lak. 116/1998 Keewwata 2 Keewwata Xiqqaa 4 fi 5 irratti ibsameen kan raawwatu ta'a.

**5. Jijjiirama Lakkoofsa Miseensota Manneen Maree Sadarkaa Hundatti Argaman**

Labsii kana Keewwata 2(3), 3(3) fi 4(6) jalatti kan tumame jiraatuyyuu, baay'ina miseensota Manneen Maree Aanaa, Gandaafi Magaalaa jijjiiruun barbaachisaa ta'ee yoo argame, Manni Maree Bulchiinsa Mootummaa Naannoo Oromiyaa Dambii baasuun murteessuudhaan ji'a 6 dura Boordii Filannoo Biyyoolessaa beeksisuu ni danda'a.

፮) የአንደኛና የሁለተኛ ደረጃ ከተማ ምክር ቤት አባላት ብዛት በአዋጅ ቁጥር ፳፭/፲፱፻፺፭ አንቀጽ ፲፫ ንዑስ አንቀጽ ፪ ስር ከተደነገገው ላይ በመነሳት ከ፵፩-፹፩ ይሆናል።

፯) በአንደኛና ሁለተኛ ደረጃ ከተማ አስተዳደር የሚካሄደውን የምክር ቤት አባላት ምርጫ አስመልክቶ የኦሮሞ ብሔርና በከተማው ዙሪያ የሚገኙ የገጠር ቀበሌ ነዋሪዎች ብዛት በተመለከተ በአዋጅ ቁጥር ፩፻፲፮/፲፱፻፺፰ በአንቀጽ ፪ ንዑስ አንቀጽ ፬ እና ፭ ስር በተደነገገው መሠረት የሚፈፀም ይሆናል።

**፮. በሁሉም ደረጃ የሚገኙ የምክር ቤት አባላት ብዛት ለውጥ**

በዚህ አዋጅ በአንቀጽ ፪(፫)፣ ፫(፫) እና ፬(፮) ስር የተደነገገው ቢኖርም የወረዳ፣ የቀበሌና የከተማ ምክር ቤት አባላት ብዛትን መለወጥ አስፈላጊ ሆኖ ከተገኘ የኦሮሚያ ብሔራዊ ክልላዊ መንግሥት መስተዳደር ምክር ቤት በሚያወጣው ደንብ በመወሰን ከ፮ ወር አስቀድሞ ለብሔራዊ የምርጫ ቦርድ ማሳወቅ ይችላል።

**፯. አዋጁ የሚፀናበት ጊዜ**

3) The election of 1st and 2nd Grade Urban Administration Council members shall be carried out on the basis of urban residents

4) Taking into consideration the number of residents, adequate proportion shall be respected for members elected from 3rd and 4th Grade Urban Administration in Woreda Council.

5) Each member of Urban Administration Council shall represent 300 to 3000 urban residents.

6) In accordance with Article 13 Sub-Article 2 of Proclamation No 65/2003 the number of members of 1st and 2nd Grade Urban Administrative Councils shall be 41-81.

7) In conducting election at 1st & 2nd Grade Urban Administrative Council regard shall be taken for the Oromo residents and rural kebele residents surrounding the respective Urban Administration in accordance with Article 2 Sub-Article 4 & 5 of Proclamation No.116/2006.

**5. Alteration of the Number of Members of Councils at All Level**

Notwithstanding the provisions of Article 2(3), 3(3) and 4(6) of this Proclamation, where it is necessary to alter the numbers of members of Woreda, Kebele, and Urban Administration Council, the Oromia National Regional State Administrative Council may determine by issuing a regulation and notify such alteration to the National Electoral Board before 6 months.

**6. Effective Date**

This Proclamation shall come into force as of November 26/2006.
