Akkaataa Heera Fooyya'aa Mootummaa Naannichaa Labsii Lak. 46/1994, Keewwata 49(3) (a) tiin kan kanatti aanu labsameera.

1. Mata Duree Gabaabaa

Labsiin kun “Labsii Biiroo Lafaafi Eegumsa Naannoo Oromiyaa Hundeessuuf Bahe Lak. 147/2001,” jedhamee waamamuu ni danda'a.

2. Hiikaa

Akkaataan jechichaa hiika biraa kan kennisiisuuf yoo ta'e malee Labsii kana keessatti:

- 1) “Mootummaa,” jechuun Mootummaa Naannoo Oromiyaa jechuudha.
- 2) “Lafa,” jechuun lafa baadiyyaafi magaala naannoo Oromiyaa keessatti argamu jechuudha.
- 3) “Itti fayyadama Lafaa,” jechuun lafa kunuunsuudhaan haala itti fufiinsa qabuun faayidaa ol'aanaadhaaf akka oolu sirna ittiin taasifamuudha.
- 4) “Bulchiinsa Lafaa,” jechuun sirna qabiyyee lafaa irratti wabiin kan ittiin kennamu, karoora itti fayyadama lafaa kan itti raawwatamu, walitti bu'iinsi itti fayyadamtoota lafaa jiddutti ka'an kan ittiin hiikamu, mirgaafi dirqama itti fayyadamaan lafa kamiyyuu kan ittiin raawwatamu, ragaa lafa abbootii qabiyyee kan ittiin walitti qabamuufi xiinxalamee itti fayyadamatootaaf akka gahu kan ittiin taasifamuudha.
- 5) “Karoora Itti fayyadama Lafaa,” jechuun ragaa haala lafaa mul'atu, kan dinagdeefi hawaasummaa bu'uura gochuudhaan lafti faayidaa adda addaa kennu keessaa lafaafi naannooratti dhiibbaafi miidhaa osoo hin qaqqaabsiisin faayidaa dinagdee ol'aanaatiif akka oolu kan ittiin murtaa'uufi hojiiirra kan ittiin oolu sirna hojii jechuudha.
- 6) “Maastar Pilaanii Itti fayyadama Lafaa,” jechuun itti fayyadama lafaa gadi fageenyaan qophaa'uuf bu'uura kan ta'e itti fayyadama lafaa gurguddaa addaan baasee ragaa agarsiisu jechuudha.

፩) “መንግሥት” ማለት የኦሮሚያ ብሔራዊ ክልላዊ መንግሥት ማለት ነው፡፡

፪) “መሬት” ማለት በኦሮሚያ ክልል ውስጥ የሚገኝ የገጠርና የከተማ መሬት ማለት ነው፡፡

፫) “የመሬት አጠቃቀም” ማለት መሬትን በአንክብካቤ ይዞ ዘላቂነት ባለው መንገድ ለተሻለ ጠቀሜታ እንዲውል የሚደረግበት ሂደት ነው፡፡

፬) “የመሬት አስተዳደር” ማለት በመሬት ይዞታ ላይ ዋስትና የሚሰጥበት የመሬት አጠቃቀም ዕቅድ የሚተገበርበት፣ በመሬት ተጠቃሚዎች መካከል የሚነሱት ግጭቶች የሚፈቱበት ማንኛውም የመሬት ተጠቃሚ መብትና ግዴታዎች የሚተገበሩበት፣ እንዲሁም የባለይዞታዎች መሬት መረጃ በመስብሰብና በመተንተን ለተጠቃሚዎች እንዲደርሱ የሚደረግበት ሂደት ነው፡፡

፭) “የመሬት አጠቃቀም ዕቅድ” ማለት አካላዊ፣ ኢኮኖሚያዊና ማህበራዊ መረጃዎችን መሠረት በማድረግ ከተለያዩ የመሬት አጠቃቀም አማራጮች መካከል በመሬትና በአካባቢው ላይ ጉዳት ሳያስከትሉ ከፍተኛ ኢኮኖሚያዊ ጠቀሜታ የሚያስገኙ አማራጮች የሚወሰንበትንና ተግባራዊ የሚደረግበት የአሰራር ዘዴ ነው፡፡

፮) “የመሬት አጠቃቀም ማስተር ፕላን” ማለት በዝርዝር ለሚዘጋጅ የመሬት አጠቃቀም ዕቅድ መሠረት የሚሆን ዋና ዋና የመሬት አጠቃቀምን የሚያሳይ መረጃ ነው፡፡

NOW, THEREFORE, in accordance with Article 49 (3) (a) of the proclamation No. 46/2001 of the Amended Constitution of the national Regional State of Oromia, it is hereby proclaimed as follows:

1. Short Title

This proclamation may be cited as the “Oromiya Bureau of Land and Environmental Protection Establishment Proclamation No. 147/2009.”

2. Definitions

In this proclamation, unless the context requires otherwise:

- 1) “Government,” means the Regional Government of Oromia.
- 2) “Land,” means the Rural and Urban land which is located in Oromia Region.
- 3) “Land Use,” means a process by which the land is sustainably used to give better outputs through proper management and conservation.
- 4) “Land Administration,” means a process whereby land tenure security is provided, land use planning is implemented, disputes and conflicts on land is resolved, and the rights and obligations of landholder are enforced and controlled and as well the land related data are collected and analyzed to be availed to users.
- 5) “Land Use Planning,” means a practice whereby the options that greater economic benefits without causing land degradation and environmental pollution are determined and implemented from among the different use options a land can give on the basis of physical, economic and social information.
- 6) “Land Use Master Plan,” means the data that indicates major land use which can be used as a base for preparation of detail land use plan.

7) “Eegumsa Naannoo,” jechuun qabeenya naannoo kamiyyuu osoo miidhaan irra hin gahin, hin faalaminiifi hin xuraayin kunuunfamee haala itti fufiinsa qabuun akka faayidaa kennu to’achuu jechuudha.

8) “Naannoo,” jechuun lafa, qilleensa, haala qilleensaa, bishaan, sagalee, foolii, dhandhama, haala hawaasummaa, miidhagina uumamaa namaan fooyya’ee ykn jijjiiramee kan jiru hundaa ta’ee, namaafi kan biroo bakka waliin jiraatan jechuudha.

9) “Odiitii Naannoo,” jechuun sirna warshaaleefi dhaabbileen misoomaa seerotaafi istaandardii eegumsa naannoo eeganii adeemuu, haala qabiinsa meeshaalee oomishaa keemikaalotaafi gataa, gahumsa raawwii meeshaalee oomishaa, itti fayyadama qabeenyaafi dhiibbaan nannoo ittiin gamaaggamamuudha.

3. Hundeeffama

Biiroo Lafaafi Eegumsa Naannoo Oromiyaa kana booda “Biiroo” jedhamee kan waamamu Labsii kanaan hundeeffameera.

4. Teessoo Ol’aanaa

Teessoon ol’aanaa Biirichaa magaalaa Finfinnee keessa ta’ee godinaalee, aanaaleefi magaalota keessatti waajjiraalee ni qabaata; achii gadittis akka barbaachisaa ta’etti waajjira ni qabaata.

5. Aangoofi Hojii Biirichaa

Biirichi aangoofi hojii armaan gadii ni qabaata.

1) Imaammataafi tarsiimoo lafaafi eegumsa naannoo qopheessee mootummaaf ni dhiyeessa, yoo hayyamames hojiirra ni oolcha; hojiirra oolmaa isaas ni hordofa; ni to’ata; raawwii seeraan alaarratti tarkaanfii ni fudhata.

፯) “የአካባቢ ጥበቃ” ማለት በየትኛውም አካባቢ ያለው ማንኛውም ሀብት ጉዳት ላይደርስበት፣ ላይበከልና ላይቆሽሽ በመንከባከብ ዘላቂ ጥቅም እንዲለጥ መቆጣጠር ማለት ነው።

፰) “አካባቢ” ማለት መሬት፣ አየር፣ የአየር ንብረት፣ ውኃ፣ ድምፅ፣ ሽታ፣ ጣዕምና ማህበራዊ ሁኔታ ወይም የተፈጥሮ ውበት በሰው ወይም በተፈጥሮ የተሻሻለ ወይም የተለወጠ ሆኖ ሰው እና ሌሎች ሌሎች በርካታ ነገሮች በጋራ የሚኖሩበት ቦታ ማለት ነው።

፱) “የአካባቢ አዲት” ማለት ፋብሪካዎችና የልማት ድርጅቶች ሕጉችና የአካባቢ ጥበቃ መስፈርቶችን ጠብቀው መሥራታቸውን፣ የማምረቻ መሣሪያዎች ኬሚካሎችና የቆሻሻ አያያዝ ሁኔታ፣ የማምረቻ መሣሪያዎች ብቃት፣ የንብረት አጠቃቀምና በአካባቢ ላይ የሚደርስ ተፅዕኖን መገምገም ማለት ነው።

፫. ስለመቋቋም

የኦሮሚያ የመሬት እና የአካባቢ ጥበቃ ቢሮ ከዚህ በኋላ “ቢሮ” ተብሎ የሚጠራ በዚህ አዋጅ ተቋቁሟል።

፬. ተቀማጭነት

የቢሮው ዋና መሥሪያ ቤት ፊንፊኔ ከተማ ውስጥ ሆኖ በዞኖች፣ ወረዳዎችና ከተሞች ውስጥ ቅርንጫፍ ጽ/ቤቶች ይኖሩታል። ከዚያ በታችም እንዳስፈላጊነቱ ጽ/ቤቶች ይኖሩታል።

፭. የቢሮው ስልጣንና ተግባር

ቢሮው የሚከተሉት ተግባርና ኃላፊነት ይኖሩታል።

፩) መሬትና አካባቢ ጥበቃን አስመልክቶ ፖሊሲዎችንና ስትራቴጂዎችን አዘጋጅቶ ለክልሉ መንግሥት ያቀርባል፣ ሲፈቀድም በተግባር ላይ ያውላል፣ ተግባር ላይ እንዲውል ይከታተላል፣ ይቆጣጠራል፣ ሕገወጥ አሠራር ላይ ሕጋዊ እርምጃ ይወስዳል፣

7) “Environmental Protection,” means the protection of any resource at any place from hazardous pollution and dirt and taking care for sustainable use.

8) “Environment,” Refers to the totality of land, air, air condition, water, voice, smell, test, social conditions, natural beauty modified or changed by man or nature all existing in numerous or condition including man and others.

9 “Environmental Audit,” means evaluating factories and development organizations whether they respect laws and environmental standards, the way of handling production instrument, chemicals, disposals, efficiency of production instruments, use of resources and their environmental impact.

3. Establishment

The Oromia Bureau of Land and Environmental Protection, here after referred to as the “Bureau” is here by established by this proclamation.

4. Head Office of the Bureau

The Head office of the Bureau shall be situated in the capital city of the region (Finfine); and it shall have branch offices at zonal and woreda and urban local government level. It shall also have office at lower levels as may be necessary.

5. Powers and Duties of the Bureau

The Bureau shall have the following powers and duties:

1) Formulate polices and strategies pertinent to land and Environmental protection; and implement or cause to be implemented upon approval; regulate and follow up its implementation; and take legal action for breach of law pertinent to land and environmental protection;

- 2) Lafa naannichaa ni bulcha; karoora itti fayyadama lafaa ni qopheessa, yoo hayyamame hojiirra ni oolcha; akka hojiirra oolu ni taasisa; hojiirra ooluu isaas ni to'ata.
- 3) Qorannoo gaggeessuudhaan maastar pilaanii itti fayyadama lafaa ni qopheessa, hojii irra oolmaa isaa ni hordofa; ni to'ata; ni haaromsa; raawwii seeraan alaa irratti tarkaanfii ni fudhata.
- 4) Lafti haala faayidaa isaatiin addaan bahee, haala barbaadameen hojii misoomaatiif akka ooluuf qaamolee adda addaatiif karoora isaa wajjin dabarsee ni kenna; raawwii isaas ni to'ata.
- 5) Seerarratti hundaa'uudhaan qabiyyee lafaa ni galmeessa; ni safara; waraqaa ragaa abba qabiyyummaa qopheessee qaama hayyamameef ni kenna; waliigaltee mirga itti fayyadama lafaa dabarsuu ni galmeessa; ni mirkaneessa.
- 6) Lafti hojii misooma adda addaatiif yammuu barbaadamu, seera irratti hundaa'ee qaama ilaallatu waliin ta'uudhaan shallaggii beenyaa ni gaggeessa; kaffaltiin akka raawwatamu ni taasisa; namoota qabiyyee isaanii gadi dhiisan deebi'anii akka dhaabbatan ni hordofa; ni to'ata.
- 7) Qorannoo hulaa misoomaafi giddugala guddinaa ni qorata, ni qorachisa; hojiirra ooluu isaas ni to'ata.
- 8) Lafaafi eegumsa naannoo ilaalchisee wal diddaa uumamu qaama dhimmi ilaallatu waliin ta'uun furmaata akka argatu ni taasisa.
- 9) Qaamolee qabeenya uumamaa seeraan ala itti fayyadamuun dhiibbaa geessisan deebisanii akka misoomsan ni taasisa; tarkaanfii seeraa ni fudhata, akka fudhatamu ni taasisa.
- 10) Lafa hojii misoomaafi tajaajila adda addaatiif ooluu danda'u qoratee ni qopheessa; qaama dhimmi ilaaluuf dhiyeessee yoo hayyamame ni kenna.

- ፮) የልማት ኮረደርና የዕድገት ማዕከል ያጠናል፤ ያስጠናል፤ ሥራ ላይ መዋሉን ይቆጣጠራል፤
- ፯) መሬት ለተለያዩ የልማት ሥራዎች ሲፈለግ ሕግን መሠረት በማድረግ ከሚመለከተው አካል ጋር በመሆን የካሣ ተመን ያዘጋጃል፤ ክፍያ እንዲፈፀም ያደርጋል፤ ይዞታቸውን የለቀቁ ሰዎች እንዲቋቋሙ ይከታተላል፤ ይቆጣጠራል፤
- ፰) በተጠቃሚዎች መካከል መሬትንና የአካባቢ ጥበቃን በሚመለከት የሚፈጠረውን አለመግባባት ከሚመለከታቸው አካላት ጋር በመሆን መፍትሔ እንዲያገኝ ያደርጋል፤
- ፱) በሕገወጥ መንገድ የተፈጥሮ ሀብትን በሚጠቀሙና ጉዳት በሚያደርሱ አካላት ላይ ሕጋዊ እርምጃ ይወስዳል፤ ወይም እርምጃ እንዲወሰድ ያደርጋል፤ መልሰው እንዲያለሙ ያደርጋል፤
- ፲) ለተለያዩ የልማት ሥራና አገልግሎት የሚውል መሬት አጥንቶ ያዘጋጃል፤ ለሚመለከተው አካል አቅርቦ ሲፈቀድ ይሰጣል፤

- 2) Administers the land resources of the region; prepare land use planning and implement or cause to be implemented upon approval; Regulate and Monitor its implementation;
- 3) Conduct studies and Prepare land use master plan and implement or cause to be implemented upon approval; regulate and follow up its implementation; appraise the master land use plan; take legal action for breach of the master plan;
- 4) Based on land use master plan, avail land information that helps for development purpose; regulate and follow up its implementation;
- 5) Undertake cadastral surveying and register the holdings, prepares land holding certificate and issues to the legal land holders; register and approve transaction agreement of land holding and use right;
- 6) Conduct studies or cause studies to be conducted on development corridors and growth centers; regulate and follow up its implementation;
- 7) In collaboration with concerned organs determines compensation to a person whose land holding has been expropriated for development works, regulate and follow up the person to be rehabilitated;
- 8) In collaboration with concerned organs resolve or cause to be resolved any conflicts or disputes arising on land and Environmental protection;
- 9) Take legal action on any individual who illegally utilize the natural resources of the region and caused damages to them; and cause the area to be rehabilitated;
- 10) Study and identify land for various development work and service and submit to concerned body; and give upon approval;

- 11) Haala qabatamaa naannichaa irratti hundaa'uudhaan madaallii sadarkaa eegumsa naannoo ni qopheessa, yeroo mirkanaa'u hojjiirra akka oolu ni taasisa; hojjiirra oolmaa isaa ni to'ata.
- 12) Hojiiwwan misoomaa adda addaa geggeeffaman kamiyyuu naannoo irratti dhiibbaa akka hin dhaqqabsiisne ni to'ata.
- 13) Sagantaaleen pirojektoota misoomaa kan Mootummaas ta'e kan dhuunfaa yeroo karoorfaman sakatta'iinsa dhiibbaa naannoo dursamee pirojektoota irratti adeemsifamu akka qabaatu ni taasisa; ulaagaalee sakatta'a dhiibbaa naannoof barbaachisu ni qopheessa, qaama barbaaduuf ni kenna; hojjiirra oolmaa isaa ni to'ata.
- 14) Hafteewwan oomisha warshaaleefi hazbaan magaalota keessaa ba'an sirna madaallii ikoolojii akka hin xureessine ni to'ata; tarkaanfii sirreeffamaa ni fudhata; ni fudhachiisa.
- 15) Ragaaleefi odeeffannoo lafaafi eegumsa naannoo ni gurmeessa; ni kuusa; ni bulchaa; haala barbaachisaa ta'een qaamni barbaadu akka argatu ni taasisa.
- 16) Warshaaleefi industiroota jiran irraa kan bahan dhangala'aafi gataawwan summii qaban uumama naannoo irratti miidhaa akka hin geessisneef oodiitii naannoo ni gaggeessa.
- 17) Haala qabatamaa rakkoo itti fayyadama lafaafi eegumsa naannoo ilaalchisee hubannoon akka cimuu ni taasisa.
- 18) Lafaafi eegumsa naannoo ilaalchisee qaamolee adda addaa wajjin walitti dhufeenya barbaachisu ni taasisa.
- 19) Iddoon jireenya lubbu qabeeyyii adda addaa miidhamee jireenya isaanii irratti balaa akka hin qaqqabsiisne ni to'ata; badii uumamurratti tarkaanfii ni fudhata; akka fudhatamu ni taasisa.
- 20) Manca'ina qabeenya uumamaa, sochii bu'aa bosonaafi bineensa bosonaa ni to'ata; tarkaanfii seeraa ni fudhata; akka fudhatamu ni taasisa.

- 19) Monitor damaging effects on habitats and divers living organisms and take corrective measures or cause to be corrected if so happened;
- 20) Regulate and monitor any damaging effects on natural resources; regulate the movement of forest and wildlife products; take or cause to be taken appropriate measures on any illegal actions;

- 1) The rights and duties of Oromia Environmental Protection Office has been transferred to the Oromia Bureau of Land and Environmental protection.
- 2) All the ongoing activities which had been started implementing by different responsible organizations before this Proclamation, would be considered as it has been started by the Oromia Bureau of Land and Environmental Protection and continued to be completed.
- 3) The Organizational structure, appointment, accountability, source of income and financial documents of the Bureau will be accomplished according to Proclamation No. 87/2004.

7. Inapplicable Laws

- 1) The regulation No. 28/2002 to establish the Oromia Environmental Protection office is hereby repealed.
- 2) The Proclamation to Amend the Oromia Rural Land Use and Administration No. 130/2007 and under Proclamation No. 132/2007 Article 2 Sub-Article 1 and Article 2 Sub-Article 15, the powers and duties upon land administration, use and regulating natural resources given to Oromia Bureau of Agriculture and Rural Development and Oromia Pastoralist Development Commission are hereby transferred by this proclamation to Oromia Bureau of Land and Environmental Protection.

The council of Oromia Regional Government shall have the power to issue regulations for implementing this proclamation.

9. Effective Date

This proclamation shall enter into force as of the 5th of March 2009.
