 has become necessary to establish an
 improved system for coffee quality control and
 marketing for Oromia;

WHEREAS, it has been found necessary to
 make the coffee marketing system fast and
 cost effective, in order to enable coffee
 producers to earn better income from coffee
 transactions;

Where as; it is necessary to enable the
 country to acquire necessary out put by
 controlling illegal coffee trade and extending
 legal market procedure;

Now therefore, the following proclamation
 is enacted in accordance with proclamation
 No. 46/1994, Article 49(3) (a) of the Revised
 constitution of Oromia National Regional
 State.

1. Mata Duree Gabaabaa

Labsiin kun "Labsii Sirna To'annoo, Qulqullinaa fi Daldala Buna Naannoo Oromiyaa murteessuuf Bahe labsii Lakk 160/ 2002" jedhamee waamamuu ni danda'a.

2. Hiika

Akkaataan jechichaa hiika biroo kan kennisiisuuf yoo ta'e malee labsii kana keessatti:-

- 1) **"Biiroo"** jechuun Biiroo Qonnaa fi Misooma Baadiyyaa Oromiyaa fi caasaalee isaa sadarkaa hundatti argaman jechuudha.
- 2) **"Buna"** jechuun haalaa fi gosa kamiiniyyuu kan argamu ija bunaa yookaan qaama ija bunaa jechuudha.
- 3) **"Buna diimaa"** jechuun ija buna uumamaan sadarkaa bilchina isaa xumuree kan sirriiti diimate jechuudha.
- 4) **"Buna janfala"** jechuun ija bunaa sirritti diimatee yeroodhaan funaanamee gogee qolli irraa hin baane jechuudha.
- 5) **"Buna Miicamaa qola keessaa waliin"** jechuun ija bunaa sirritti diimatee funaaname muluqe, bukaa'ee, miicamee fi qola keessaa waliin kan goge jechuudha.
- 6) **"Buna miicamaa"** jechuun buna teekniika hojimaata qophii buna miiccaatiin qophaa'ee qolli keessaa kan irraa ba'e jechuudha.
- 7) **"Buna hin miicamne"** jechuun ija bunaa diimatee funaanamee fi gogee warshaa buna qulqulleessu keessatti qolli isaa irraa bahee qophaahe jechuudha.
- 8) **"Buna hanga tokko miicame"** jechuun ija bunaa diimatee warshaalee buna jiidhaatiin muluqee happee isaa Waliin gogee qophaa'e jechuudha.
- 9) **"Buna dhiheessuu"** jechuun buna bifa kamiyyuu bakka bunni itti oomishamu irraa warshaa bunaa qopheessanitti qophaa'e gara giddugaleessa gabaa oomishaa Itoophiyaatti kan dhihaatu jechuudha.

- 1) «**ቢሮ**» ማለት የኦሮሚያ ግብርና እና የገጠር ልምት ቢሮ እና በሁሉም ደረጃ የሚገኙ መዋቅሮች ማለት ነው፡፡
- 2) «**ቡና**» ማለት በማንኛውም ሁኔታ እና ዓይነት የሚገኝ የቡና ፍሬ ወይም የቡና ፍሬ አካል ማለት ነው፡፡
- 3) «**ቀይ እሽት ቡና**» ማለት በተፈጥሮ የብስለት ደረጃውን አጠናቆ በትክክል የቀላ ቡና ፍሬ አካል ማለት ነው፡፡
- 4) «**ጀንፈል ቡና**» ማለት በትክክል ቀልቶ በወቅቱ ተለቅሞ ደርቆ ገለባዊ ያልወጣለት የቡና ፍሬ ማለት ነው፡፡
- 5) «**የታጠበ ቡና ከነገለፈቱ**» ማለት በትክክል ቀልቶ በወቅቱ ተለቅሞ በእሽት የተፈለፈለና የቦካና የታጠበን ከወስጥ ገለባዊ ጋር የደረቀ ማለት ነው፡፡
- 6) «**የታጠበ ቡና**» ማለት በቡና እጥበት ዝግጅት አሰራር ተከኒካ ተዘጋጅቶ የወሰጥ ገለባዊ የወጣለት ማለት ነው፡፡
- 7) «**የልታጠበ ቡና**» ማለት ቀልቶ ተለቅሞ እና ደርቆ በቡና ማጣሪያ ፋብሪካ ውስጥ ገለባዊ ወጥቶለት የተዘጋጀ የቡና ፍሬ ማለት ነው፡፡
- 8) «**በክፍል የታጠበ ቡና**» ማለት ቀልቶ በእሽት ቡና ፋብሪካዎች ተፈልፍሎ ከወስጠኛው ቅርፊቱ ጋር ደርቆ የተዘጋጀ የቡና ፍሬ ማለት ነው፡፡
- 9) «**ቡና ማቅረብ**» ማለት ማንኛውም ዓይነት ቡና ከሚመረትበት ቦታ በቡና ማዘጋጃ ፋብሪካ ተዘጋጅቶ ወደ ኢትዮጵያ የምርት ገበያ ማዕከል የሚቀርብ ማለት ነው፡፡

Part One

General Provisions

1. Short title

This proclamation may be cited as "proclamation enacted to decide the procedure of coffee quality control and coffee trade in Oromia, proclamation No.160/2010"

2. Definitions

Unless the context requires otherwise, in this proclamation;

- 1) **"Bureau"** means Oromia Agriculture and rural development Bureau and its structures at all levels.
- 2) **"Coffee"** means the fruit of a coffee tree or parts of such fruits in whatever form;
- 3) **"Red cherry coffee"** means the red fruit of a coffee tree picked after it is naturally ripened;
- 4) **"Coffee with pulp"** means a red cherry coffee picked and dried but not pulped;
- 5) **"Washed coffee with parchment"** means red cherry coffee which has been pulped, fermented, washed and dried with its husk;
- 6) **"Washed coffee"** means red cherry coffee which has been pulped, fermented, washed to remove its sticky mucilage;
- 7) **"Sun dried"** means a red cherry coffee which has been dried, hulled, cleaned and sorted;
- 8) **"Semi-washed coffee"** means dried and pulped red cherry coffee with its sticky mucilage;
- 9) **"Supply coffee"** means coffee processed in any form by industries located in the production area for delivery to auction centers or the Ethiopia Commodity Exchange;

10) **“Buna gabaa biyya alaatiif dhihaatu”** jechuun, ergitootni bunaa gara giddugaleessa Gabaa Oomishaa Itoophiyaa irraa caalbaasiin buna bitanii yookaan oomishtooti bunaa qonnaan bultoonni maasii isaanii irraa buna oomishame sadarkaa qulqullina maqaa biyyattii eeguu fi bifa barbaadamuun qophaa’ee buna gabaa biyya alaatti dhihaatu jechuudha.

11) **“Buna gabaa biyya keessaaf dhihaatu”** jechuun, dhiheessiin bunaa yookaan bunnii gabaa alaaf yemmuu qophaa’u haftee buna argamuu fi qabiyyee bunichaa keessaa buna qulqulluu %15 hin caalle kan itti makame yookaan sababa addaa addaatiin yeroo dheeraaf turuudhaan gabaa biyyaa alaatiif ga’umsa kan hin qabne yookaan hanqina qabinsaatiin dhamdhamni isaa gadi aanaa ta’ee fayyaa namaa irratti miidhaa kan hin qaqqabsiifne fi gabaa biyya keessaaf kan dhihaatu jechuudha.

12) **“Buna marbuusha”** jechuun, haala hojimaata duubatti hafaa ta’een mooyyee yookaan dhagaa daakuun fayyadamuun buna qophaa’e jechuudha.

13) **“Bittaa fi gurgurtaa bunaa”** jechuun, Oomishtootaa fi Dhiheessitoota, dhiheessitootaa fi ergitoota, yookaan ergitootaa fi daldaltoota biyya alaa buna bitan yookaan ergan gidduutti adeemsa isaa eeggatee bittaa fi gurgurtaa raawwatamu jechuudha.

14) **“Buna akooftuu”** jechuun, hayyama daldala buna akaawuu baafachuun daldaala jimlaa bunaa irraa buna bitee akaa’ee yookaan akaa’ee daakee gabaa biyya keessaa fi biyya alaatti kan dhiheessu jechuudha.

15) **“Buna qopheessuu”** jechuun, hojimaata teekniikaa hayyamameen buna diimaa funaanamee muluqee qophaa’e yookaan buna janfala warshaa buna gogaatti qulqullaa’ee fi sadarkaa qulqullina isa eeggatee gabaa biyya alaatiif fedhii maamiltootaa irratti hundaa’ee kan qophaa’e jechuudha.

10) **«ለውጭ ሃገር ገበያ የሚቀርብ ቡና»** ማለት የቡና ላኪዎች ከኢትዮጵያ ምርት ገበያ ማዕከል በጨረታ ቡና ገዝተው ወይም የቡና አምራቾችና አርሶ አደሮች/ከማላቸው የተመረተውን ቡና የሃገሪቷን ስም በሚጠብቅ የጥራት ደረጃ እና በሚፈለገው መልኩ ተዘጋጅቶ ለውጭ ገበያ የሚቀርብ ቡና ማለት ነው።

11) **«ለሃገር ውስጥ ገበያ የሚቀርብ ቡና»** ማለት የቡና አቅርቦት ወይም ለውጭ ቡና ሲዘጋጅ የሚገኘው የቡና ትራፊ እና ከቡናው ይዘት ውስጥ አስራ አምስት በመቶ (15%) ያልበለጠ ጥራት ያለው ቡና የተቀላቀለበት ወይም በተለያዩ ምክንያቶች ለረጅም ጊዜ በመቆየት ለውጭ ሃገር ገበያ ብቃት የሌለው ወይም በአያያዝ ጉድለት ጣዕሙ ዝቅተኛ የሆነ በሰው ጤና ላይ ጉዳት የማያስከትል እና ለሃገር ውስጥ ገበያ የሚቀርብ ማለት ነው።

12) **«መርቡሻ ቡና»** ማለት ኃላቀር በሆነ አስራር በመቀጫ ወይም በድንጋይ ወፍጮ በመጠቀም የተዘጋጀ ቡና ማለት ነው።

13) **«የቡና ግዥ እና ሽያጭ»** ማለት አምራቾች እና አቅራቢዎች፣ አቅራቢዎች፣ ላኪዎች ወይም ላኪዎች እና ቡና የሚገዙ የውጭ ሃገር ነጋዴዎች መካከል ሂደቱን ጠብቆ የሚከናወን ግዥ እና ሽያጭ ማለት ነው።

14) **«ቡና ቆይ»** ማለት የቡና መቁላት ንግድ ፈቃድ በማውጣት ከቡና ጅምላ ነጋዴ ቡና ገዝቶና ቆልቶ ወይም ቆልቶና ፈጭቶ ለሃገር ውስጥ ገበያ የሚቀርብ ማለት ነው።

15) **«ቡና ማዘጋጀት»** ማለት በተፈቀደው የቴክኒክ አሠራር ተለቅሞና ተፈልፍሎ የተዘጋጀ ቀይ ቡና ወይም በደረቅ ቡና ፋብሪካ የተፈለፈ እና የጥራት ደረጃውን ጠብቆ ለውጭ ሀገር ገበያ ደንበኞች ፍላጎት ላይ ተመስርቶ የተዘጋጀ ማለት ነው።

10) **“Export coffee”** means coffee bought by exporters from auction centers or the Ethiopia Commodity Exchange or produced on their own farm, prepared and processed, in accordance with the country’s quality standard, for export;

11) **“Domestic consumption coffee”** means coffee which is coffee by product, or coffee the taste of which has deteriorated due to mishandling or length in storage and with not more than 15% purity, which is not harmful to health but is not fit for export;

12) **“Traditionally processed coffee”** means coffee processed using outdated methods of wood or stone grinder;

13) **“Coffee transaction”** means the lawful buying and selling of coffee between a coffee supplier and a coffee exporter, a coffee exporter and a foreign coffee importer, or coffee exporter and a domestic consumption wholesaler or a coffee supplier and a domestic consumption coffee wholesaler or a domestic consumption coffee wholesaler and retailers

14) **“Coffee roaster”** means a person who, upon being licensed by the appropriate government organ purchases coffee from auction centers, the Ethiopia Commodity Exchange, or a domestic consumption coffee wholesaler, roasts or roast and grinds coffee for export or sale in the domestic market;

15) **“Coffee processing”** includes collecting and pulping red cherry coffee after picking, pulping and cleaning coffee with pulp, and processing export coffee in accordance with the country’s quality and grade requirements and the buyers’ needs as per the authorized technical procedures;

16) “*Buufata qorannoo qulqullina fi galmee bunaa*” jechuun, qulqullina bunaa sadarkaa duraa qoratee fi galmeessee gara giddugaleessa gabaa oomisha Itoophiyaatti akka ergu qaama biiroodhaan hundaa’e jechuudha.

17) “*Dhiheessituu Bunaa*” jechuun, ulaagalee barbaachisaa ta’an guuttachuudhaan buna janfala yookaan buna diimaa oomishtoota bunaa irraa yookaan qonnaan bulaan maasii isaa irraa walitti qabee qopheessuudhaan gara giddugaleessa gabaa oomisha Itoophiyaatti kan dhiheessu jechuudha.

18) “*Daldalaa bunaa*” jechuun buna Oomishtoota irraa walitti qabee qopheessee gara giddugaleessa gabaa omisha Itoophiyaatti kan dhiheessuu, biyya alaatti erguu, akaawuu, daakuu, raabsuu, fi chirchaaroon (qinxaaboo) kan gurguruu dha.

19) “*Daldalaa jimilaa bunaa*” jechuun, buna itti fayyadama biyya keessaatiif oolu gabaa oomishaa Itoophiyaa irraa bituudhaan naannoo hayyamameeffitti qofa kan dhiheessu jechudha.

20) “*Daldalaa qinxaaboo bunaa*” jechuun nama ulaagaalee barbaachisaa ta’e guuttatee hayyama baafachuun daldalaa jimilaa bunaa irraa buna bitee kallattiidhaan ittifayyadamtootaatti kan gurguru jechuudha.

21) “*Gabaa sadarkaa tokkooffaa*” Jechuun, bakka bunnii itti oomishamutti sirna bittaa fi gurgurtaan qonnaan bulaa fi daldaltoota buna dhiyeesitoota gidduutti kan gaggeefamu fi bakki gabaa kunis koree sadarkaa Aanaatiinii fi hirmaannaa ummataatiin kan filatamee daangeefame jechuudha.

16) «የጥራት ምርመራ ጣቢያ እና የቡና ምዝገባ» ማለት የቡናውን የመጀመሪያ የጥራት ደረጃ መርምሮ እና መዘግቦ ወደ ኢትዮጵያ ምርት ገበያ ማዕከል እንዲልክ በቢሮ የተቋቋመ አካል ማለት ነው።

17) «የቡና አቅቢ» ማለት አስፈላጊ የሆኑ መመዘኛዎችን በማሟላት ጀንፈል ወይም ቀይ ቡና ከቡና አምራቾች ወይም አርሶ አደሮች ከማሳ ላይ ለበስቦ በማዘጋጀት ወደ ኢትዮጵያ የምርት ገበያ ማዕከል የሚያቀርብ ማለት ነው።

18) «የቡና ነጋዴ» ማለት ከአምራቾች ላይ ቡና ለበስቦና አዘጋጅቶ ወደ ኢትዮጵያ ምርት ገበያ የሚያቀርብ ወደ ዉጭ ሀገር የሚልክ፣ የሚቆላ፣ የሚፈጭ፣ የሚያከፋፍል እና በችርቻሮ የሚሸጥ ነው።

19) «ጅምላ የቡና ነጋዴ» ማለት ለሀገር ውስጥ ፍጆታ የሚወልድ ቡና ከኢትዮጵያ ምርት ገበያ ድርጅት በመግዛት በተፈቀደለት አካባቢ ብቻ የሚያቀርብ ማለት ነው።

20) «የቡና ችርቻሮ ነጋዴ» ማለት አስፈላጊ የሆነውን መመዘኛ አሟልቶ ፈቃድ በማውጣት ከቡና ነጋዴ ላይ ቡና ገዝቶ በቀጥታ ለተጠቃሚዎች የሚሸጥ ማለት ነው።

21) «አንደኛ ደረጃ ገበያ» ማለት ቡና በሚመረትበት ቦታ በአርሶ አደሮች እና በቡና አቅራቢ ነጋዴዎች መካከል የሚካሄድ የግዥ እና ሽያጭ ስርዓት እና ይህ የገበያ ቦታም በወረዳ ደረጃ ከማቴ እና በሕዝብ ተሳትፎ ተመርጦ የተከለለ ቦታ ማለት ነው።

16) “Coffee quality control and registration center” means a body established by the bureau to carry out first level quality control and register such coffee and then send to Ethiopian central market.

17) “Coffee supplier” means a person who, upon meeting the required criteria, collects coffee with pulp or red cherry coffee from producers or from his own farm for delivery to the Ethiopia Commodity Exchange;

18) “Coffee merchant” means a dealer that collects coffee from producers and processes it and then supplies Ethiopian central market, export roast, ground, distribute and sells coffee in retail.

19) “Coffee wholesaler” means a supplier who buys coffee from Ethiopian central market, and supplies to internal markets only at authorized areas for domestic consumption.

20) “Coffee retail merchant” means a merchant who gets trade license to directly sell coffee to consumers buying from coffee wholesaler, fulfilling all necessary requirements.

21) “1st grade market” means a market place at coffee production site where the transaction is performed between farmers and coffee supplier merchants and this place is selected and demarked by committee established at district level and public participation.

22) **“Giddugaleessa gabaa oomisha Itoophiyaa”** jechuun bakka daldaltoonni buna dhiyeesitoota buna gabaa sadarkaa tokkoffaa irraa bitan, qopheesanii fi haala seera qabeessan bakka bittaa fi gurgurtaan bunaa itti raawwatuudha.

23) **“Haftee bunaa”** jechuun, buna firii isaa sirritti kan hin guuttanne, ulfina kan hin qabne, caccabaa fi qola bunaa yookaan hanqinoota biraa kan qaban ta’ee, gabaa biyya alaatiif kan ooluu hin dandeenye jechuudha.

24) **“Keellaa to’annoo bunaa”** jechuun, iddoo yookaan buufata to’annoon daldala bunaa seera qabeessummaan isaa itti mirkanaa’ee darbuu fi daldalli seeraan alaa itti to’atamu jechuudha.

25) **“Koree”** jechuun, koree sadarkaa naannootii hanga gandaatti dhaabbatee hojii misooma fi to’annoo daldala bunaatiif deeggarsa kennu jechuudha.

26) **“Oomishtoota bunaa”** jechuun, qonnaan bultoota xixiqqaa buna oomishan, waldaalee fi Yuuniyeenii oomishtoota bunaa, abbootii qabeenyaa dhuunfaa fi dhaabbilee mootummaa buna oomishan hunda kan dabalatu jechuudha.

27) **“To’annoo qulqullina bunaa”** jechuun, oomishitoonni bunaa amala uumamaan qabu eegee ittifayyadamtootaaf akka dhihaatu hojiin buna funaanuu, qopheessuu, kuusuu fi geejibuu sirna hojimaata hayyamameen akka raawwatu gochuuf hojii to’annoo qulqullinaa fi daldala bunaa sadarkaa hundaatti raawwatu jechuudha.

28) **“To’ataa Qulqullina bunaa”** jechuun, akkaataa labsii kanaatiin bunni qophaa’uu fi daldalli bunaa geggeeffamuu isaa akka too’atu nama biiroon ramaduu jechuudha.

25) **«ኮሚቴ»** ማለት ከክልል ደረጃ እስከ ቀበሌ ተቋቁሞ ለቡና ልማት እና ንግድ እና ቁጥጥር ድጋፍ የሚሰጥ ማለት ነው።

26) **«የቡና አምራቾች»** ማለት ቡና የሚያመርቱ ጥቃቅን አርሶ አደሮች እና ማህበራት እና የቡና አምራች ዩኒየኖች እና የግል ባለሀብቶች እና ቡና የሚያመርቱ መንግሥታዊ ድርጅቶችን ሁሉ የሚጨምር ማለት ነው።

27) **«የቡና ጥራት ቁጥጥር»** ማለት የቡና ምርት በተፈጥሮ ያለውን ባሕሪይ ጠብቆ ለተጠቃሚወዎች እንዲቀርብ የቡና ለቀማ ሥራ፣ የማዘጋጀት፣ የማከማቸት እና በዘመንዊ አሰራር ትራንስፖርት እንዲከናወን ለማድረግ በሁሉም ደረጃዎች የሚፈጸም የቡና ጥራት ንግድ እና ቁጥጥር ማለት ነው።

28) **«የቡና ጥራት ተቆጣጣሪ»** ማለት በዚህ አዋጅ መሠረት የሚዘጋጀው ቡና እና የሚካሄደው የቡና ንግድ እንዲቆጣጠር ቢሮው የሚመድበው ሰው ማለት ነው።

22) **“Ethiopian Commodity Exchange Center”** means a market where legal coffee transactions are carried in which coffee supplier merchants buy coffee from first level markets, prepare coffee and supply to this market.

23) **“Coffee by product”** means light, broken, underdeveloped or including any coffee with defects:

24) **“Coffee Control Station”** means the place or station where the legality of the coffee trade is controlled and passes while illegal coffee trade is secured.

25) **“Committee”** means Committee organized at Regional level down to Kebele level to provide support for coffee development and coffee trade activities.

26) **“Coffee producers”** means any coffee producer, including small-scale coffee farmers, coffee farmers’ co-operatives, private investors, and state coffee producing enterprises;

27) **“Coffee quality control”** means inspection and control of the picking, processing, storage and transportation of coffee, in accordance with acceptable norms, to ensure delivery of coffee to consumers in its natural state;

28) **“Coffee Quality Controller”** means personal assigned by bureau to control whether the coffee prepared and coffee trade is done in accordance with the provisions of this proclamation.

፭. የቡና ንግድ አስራር
የቡና ንግድ አስራር በሚከተለው ሁኔታ ይከናወናል፡-

- 1) በቡና አምራቾች እና አቅራቢዎች መካከል በተከለለው የአንደኛ ደረጃ የቡና ገበያ ውስጥ የቀይ እና የጀንፈል ቡና ግዥ እና ሽያጭ ይከናወናል።

29) “*Competence certificate*” means a document that certifies the ability of a person to collect, process, store, transport coffee, and to engage in all other activities related to coffee trade;

3. Gender Expression

In this Proclamation, any statement expressed in masculine shall also apply to feminine.

4. Scope of Application

This Proclamation shall apply to any person directly or indirectly involved in transactions, quality control and marketing of coffee in Oromia Regional State.

Part Two **Quality Control and Coffee Trade**

5. Coffee Transaction Process

Coffee transaction shall be executed as follows:

- 1) Coffee transaction between a coffee producer and coffee supplier shall take place in lawful first level coffee transaction centers demarcated for this purpose;
- 2) The coffee purchased at first grade coffee market center shall be prepared properly and it shall be sent to Ethiopian Commodity Exchange being accomplished by covering letter given by the bureau.
- 3) Coffee which is confiscated while being transported illegally shall be sold to legal red and dry husked coffee suppliers, the washed coffee and its by-products shall be supplied to and sold at Ethiopian Commodity Exchange.

6. Hojimaata To'annoo Qulqullina Bunaa

- 1) Bunni buufata qorannoo fi galmee bunaatti dhihaatee qorannoon sadarkaa duraa hojjetaa to'annoo qulqullinaa fi daldala bunaatiin taasifamee samasamuun waraqaa geeggessituutiin gara giddu galeessa gabaa oomisha Itiyoophiyaa ni ergama.

4) The bureau shall get any information regarding whether the coffee sent from Oromia Region to Ethiopian Commodity Exchange arrived properly, the grade given to it, sales price and other necessary information from time to time from concerned bodies. These concerned bodies shall be determined by the rule to be established.

6. Coffee Quality control producer

- 1) The coffee supplied to inspection and registration center shall undergo primary inspection done by coffee quality and trade controller staff and it is then sealed and sent to Ethiopian Commodity Exchange with accompanying letter.
- 2) The Bureau may take a sample from coffee supplied to Ethiopian Commodity Exchange and coffee stored in merchants' ware house for necessary research data.
- 3) Where the vehicle prepared to load the coffee and the coffee which is prepared to be loaded has not meet the standard, the coffee quality controller shall order for correction.

Part Three

Criteria to issue Certificate of competency for coffee trade activity

7. Criteria required to give Certificate of competency of coffee trade for coffee suppliers.

Any person who requests to get certificate of competency for coffee trade to engage in coffee supplier activities shall meet the following criteria:

- 1) Buy and prepare red coffee and to dry husked coffee from producers at a place demarked as first grade coffee market.

3) The dealer who has no facilities mentioned under sub articles 2 may be given a competency certificate if he/she rented these facilities from others.

4) Have a professional who has sufficient educational qualification or experience in coffee quality and preparation and service providing office.

8. Criteria required to give Certificate of competency of coffee trade for coffee prepares:

Any person who requests to get certificate of competency to engage in coffee preparation activities shall fulfill the following criteria

1) have his/her own coffee warehouse, coffee purifier factory, or coffee washing plant or gets from other bodies through agreement, dry bed and plain flat, balance, sacks and similar facilities.

2) have an expert who has sufficient educational qualification or experience in coffee quality and preparation and service providing office.

3) Whether the site for building coffee washing plant is suitable, safe from harm to health and environmental friendly shall be proved by concerned body to be established by regulation to be enacted for this purpose.

4) The expert of the Bureau shall approve whether the Coffee mill built may fulfill the set standard to wash coffee

5) The expert shall approve a factory which is preparing washed coffee is planted at area where sufficient water is available and utilizes modern technology to avoid water pollution by effluent of the factory.

9. Criteria required to grant certificate of competency of coffee trade for a dealer who requests to engage in coffee storage service.

Any person who asks to get certificate of competency to involve in providing coffee storage service shall meet the following requirements.

1) Shall have standard warehouse, balance verified by authorized governmental body different vouchers printed for coffee trade activities, service providing office and skilled staff.

2) Shall provide service of storing coffee with a proper arrangement of similar features together and returns the coffee received properly.

10. Criteria required to provide competency certificate for a person engaging in coffee wholesales trade

Any person who requests to get certificate of competency on coffee wholesale shall fulfill the criteria set below:

- 1) Have coffee shop.
- 2) have new or standard sacks and standard balance which is verified by authorized governmental body.

12. Application to be submitted so as to get certificate of competence for coffee trade and preparation.

- 1) Any person who requests to get certificate of competency for coffee trade and preparation shall submit its application to the bureau.
- 2) The bureau shall investigate and respond to the application within ten working days starting from the date of the application.
- 3) The bureau should address the customer specifying the reasons if the application has not met the necessary requirements.

 Any person involved in coffee transaction shall:

- 1) conduct coffee transaction only in transaction centers;
- 2) Ensure before loading coffee for transportation, that a vehicle and its driver conform to sub article 5 of Article 19 of this Proclamation.
- 3) own the proper coffee processing and storage facility as well as equipments and personnel, or submit a contract of hire of the same, in accordance with the competence certification process;
- 4) submit a representative sample from the coffee prepared for transaction when so requested for quality inspection purposes;
- 5) have the appropriate executive body seal and issue a letter of release when transporting coffee from the production area to coffee quality liquoring and inspection center or from coffee quality liquoring and inspection center to market centers and to local consumption markets;
- 6) maintain a register of the daily coffee exchange quantity, grade, price and list of purchase and disclose such register to the relevant government organ on demand and cooperate when physical presence for site visit or inventorying is required;

7) Gochaalee qulqullinaa fi sadarkaa bunaa irratti miidhaa geessisan irraa of qusachuu qaba.

3) within six month of processing, deliver processed supply coffee to auction centers or the Ethiopia Commodity Exchange for sale;

4) ensure that the coffee submitted to coffee quality liquoring and inspection centers conforms to quality standards and has a moisture content of not more than 12%;

5) purchase, process and transport coffee only in the area designated to him

6) Supply different types of coffee produced at various locations separately without mixing them.

7) Never buy and supply coffee prepared traditionally

8) Receive competency certificate for coffee trade from the bureau

15. Obligations of coffee wholesales.

Any domestic consumption coffee wholesaler shall:

2) Monitor, procedures and techniques necessary for coffee collecting, drying, transporting, preparation and sales

3) Not prepare coffee in an impure way,

19. *Obligations of the service providers* Any person who engages in coffee preparation, storage and transportation service shall:

1) Take competency assurance certificate from the bureau.

2) Give certificate/document that indicates level of standard of the service provided.

3) Prevent the husk or any odor emanating from liquid waste produced by the cleaning and pulping process from causing any negative impact on the environment

4) The owner of a vehicle that sustained malfunctions or against which a crime is committed while transporting coffee, shall promptly report the same to a lawful organ in the locality.

- 7) The warehouse service provider should properly store coffee relived to provide such service keeping its quality and standard based on the agreement.

Part Five

Miscellaneous Provisions

20. Power and Duties of the Bureau

The Bureau will have the following power and duties

- 1) determine, in consultation with Committee, 1st grade coffee transaction places and quality control;

- 2) inspect and grant certificate of quality and issue a letter of release to all coffee to be sent to Ethiopian Commodity Exchange;

- 3) cause any coffee to be sent to Ethiopian Commodity Exchange that does not meet the required quality standard to be reprocessed for compliance with the required quality and grade;

- 4) Issues competency certificate, provides support to encourage renewal and cancels otherwise.

- 5) Shall provide letter of permit so that sample coffee moves with in and out of the Region.

- 6) The Bureau can take 3kg sample from up to 10,200 kg (carrying capacity of freight truck) coffee prepared to be sent to Ethiopian Commodity Exchange.

1) fails to comply with the appropriate technical procedures and thereby causes damage to the quality of the coffee or the local community shall have his processing plant closed and be prohibited from transporting his coffee to transaction centers, and unless punishable by greater penalty as per any other relevant law, be penalized by a fine of Birr 20,000 and an imprisonment of not less than one year but not exceeding three years.

4) unlawfully or in an inappropriate manner transports coffee shall, in addition to confiscation of the coffee, unless punishable with a greater penalty as per any other relevant law, be penalized by a fine of Birr 50,000 and an imprisonment of not less than three years but not exceeding five years.

24. Power of Jurisdiction

Courts at different level shall have power of jurisdiction to rule criminal actions mentioned under Article 23.

26. Transitional Provisions

- 1) Criminal and Civil argument cases which are already under way shall get final resolution according to the way they are handled.
- 2) Competency assurance certificate and trade licenses which are in action before the declaration of this proclamation shall remain valid until they are replaced in accordance with this proclamation.

27. Power of Enacting a Regultaion

Oromia Regional Government Council The Council of Ministers may issue regulations necessary for the implementation of this Proclamation.

28. Obligation to provide support

- 1) Any person has an obligation to provide support and assistance in the effort made to implement the issues stated in this decree.
- 2) The police should give especial support in the implementation of this proclamation; such support will be established in the rule to be enacted.

29. Effective date of the proclamation

This proclamation shall enter in to force as of 7th of July 2010.
