5. Mirga Sooramaa

 - (b) Sababa dhukkubaatiin ittigaafatamummaa irraa yoo ka'e dургоон soorama dhukkubaa umrii guutuu ni kafalamaaf.
 - (c) Hojii irra osoo jiruu du'aan addunyaa kanarraa yoo boqate bakka bu'ota isaatif dургоон sooramaa ni kanfalamaaf.

Proclamation No. 161/2010

**Rights and Benefits of Out-going Government Appointees,
Members of Caffee Oromia, and Judges Proclamation of
the Oromia National Regional State.**

WHEREAS, it is necessary that out-going Government Appointees, Members of Caffee Oromia, and Judges shall be guaranteed a life that free of depressing conditions and need to be protected from victimization in consideration of the services they provided to the Region and the public by shouldering huge public trust during their terms in office;

WHEREAS, it is necessary to create enabling conditions to take advantage of the knowledge and experience of out-going Government Appointees, Members of Caffee Oromia, and Judges accumulated through their terms in office;

WHEREAS, serving out-going Government Appointees, Members of Caffee Oromia, and Judges need to be encouraged to positively and faithfully exert their utmost effort for the development and progress of the Region without worrying about their future;

NOW, THEREFORE, in accordance with Article 49 Sub-Article3 (a) of the Revised Constitution of Oromia Regional State, it is hereby proclaimed as follows:

SECTION ONE

GENERAL

1. Short Title

This Proclamation may be cited as the "Rights and Benefits of Out-going Government Appointees, Members of Caffee Oromia, and Judges Proclamation No. 161 /2010."

- 1) "Beneficiary" means those who are entitled to the rights and benefits under this Proclamation;
- 2) "Family" includes the spouse and children of a beneficiary who are under the age of 21 years;
- 3) "Survivor" shall have the meaning given under the relevant Pension Law;
- 4) "One Election Term" means five years;
- 5) "Out-going Government Appointees" means any beneficiary under this Proclamation who is not found guilty of an offence.

3. Scope of Application

This proclamation shall be applicable to Out-going Government Appointees, Members of Caffee Oromias, and Judges.

4. Gender Reference

Any expression in the masculine gender includes the feminine.

SECTION TWO

Rights and Benefits of Out-going Government

Appointees, Members of Caffee Oromia, and

Judges

5. Pension Rights

- 1) Notwithstanding any provision to the contrary under the relevant pension law if a Regional President, Vice President, Heads and Vice Heads of Bureaus, Administrator and Vice Administrator of Zone, or Governmental Appointees of the same positions who serve at least one term or more in office:
 - (a) Attained the age of 50 and above at the time of his retirement, he shall receive retirement pension for life;
 - (b) Retires because of illness, he shall receive invalidity pension for life;

- 2) If a President, Vice President, Heads and Vice Heads of Bureaus, Administrators and Vice Administrators of Zones, or Governmental Appointees of the same positions serve less than one full term in office shall be paid maintenance allowance if he leaves his/her position;
 - (a) has attained the age of 50 at the time of his retirement, he shall receive retirement gratuity;
 - (b) retires because of not fulfilling the medical condition of service, he shall receive invalidity gratuity;
- 3) The amount of pension and gratuity payable under this Sub-Article 1 and 2 of this Article shall be determined in accordance with the relevant provision of pension law;
- 4) The money spent on this article shall be covered by Regional Government;

6. Maintenance Allowance

- 1) President, Vice President, Heads and Vice Heads of Bureaus, Administrators and Vice Administrators of Zones, or Governmental Appointees of the same positions;
 - (a) after serving for not less than one election term or in office;
 - (b) due to sickness, disability or any other ground caused by force majeure upon completing at least half of one election term;
- 2) The amount of maintenance allowance to be paid pursuant to Sub-Article 1 of this Article, a President, Vice President, Heads and Vice Heads of Bureaus, Administrators and Vice Administrators of Zones or Governmental Appointees of the same positions, shall be equivalent to three month's salary for the first year of service, and one month's salary shall be added for every additional year of service; provided, however, that the total amount of maintenance allowance shall not exceed 18 month's salary.

7. Severance Pay

- 1) A President, Vice President, Heads and Vice Heads of Bureaus, or Governmental Appointees of the same positions, Administrators and Vice Administrators of Zones who have been released from the office shall be entitled to severance pay; provided, however, that a Member who is *not* reinstated to his former job,
- 2) The amount of severance pay to be paid pursuant to Sub-Article 1 of this Article shall be equivalent to three month's salary for the first year of service, and one third (1/3) of the monthly salary shall be added for every additional year of service.
- 3) The provision of Sub-Article 2 of this Article, however, the total amount of severance pay shall not exceed one year's salary.

8. Housing Allowance

- 1) A President, Vice President, Heads and Vice Heads of Bureaus, Administrators and Vice Administrators of Zones or Governmental Appointees of the same positions shall be paid housing allowance if he has been released from the office;
 - a) After serving for at least one election term; or
 - b) Due to sickness, disability or any other ground cause by force majeure upon completing at least half of one election term;
- 2) The housing allowance under Sub-Article 1 of this Article shall be paid in a lump sum and its amount shall be

- (a) In the case of President, or Vice President, six month's full payment for the initial service and an addition of half of the monthly payment for every additional year of service beyond the first election term;
- (b) In the case of Heads, or Governmental Appointees of the same positions, three month's full payment for the initial service and an addition of half (1/2) of the monthly payment for every additional year of service beyond the first election term;
- (c) In the case of Deputy Heads of Bureaus, or Governmental Appointees of the same positions, Administrators and Deputy Administrators of Zones, and Governmental Appointees of the same positions, two month's full payment for the initial service and an addition of half of the monthly payment for every additional year of service beyond the first election term;
- 3) Provided, however, that the total amount of severance pay shall not exceed 18 month's housing allowance.

9. Vehicle Allowance

- 1) A President, Vice President, Heads and Vice Heads of Bureaus, or Governmental Appointees of the same positions, Administrators and Vice administrators of Zones shall be paid vehicle allowance if he has been released from the office;

- b) due to sickness, disability or any other force majeure upon completing at least half of one election term;
- 2) The vehicle allowance under Sub-Article 1 of this Article shall be paid in a lump sum and its amount shall be:
- (a) in the case of a President, or Vice President, six month's full salary for the initial service and an addition of half of the monthly salary for every additional year of service beyond the first election term;
- (b) in the case of Heads of Bureaus, or Governmental Appointees of the same positions, three month's full payment for the initial service and an addition of half (1/2) of the monthly payment for every additional year of service beyond the first election term;
- (c) in the case of Vice Heads of Bureaus, or Governmental Appointees of the same positions, Administrators and Vice administrators of Zones, and Governmental Appointees of the same positions, two month's full payment for the initial service and an addition of half (1/2) of the monthly payment for every additional year of service beyond the first election term;
- 3) Provided, however, that the total amount of severance pay shall not exceed 18 month's salary.

10. Medical Benefits

- 1) A President and Vice President:
- (a) shall get free medical services for himself and his family in local public health institutions or, where appropriate, in private health institutions at the expense of the government;

- (b) may get overseas medical services at the expense of the government when recommended by a medical board;
 - (c) Where a President and Deputy President and his spouse are admitted to a local public health institutions, they shall be entitled to first class inpatient services.
- 2) Heads of Bureaus, Administrators of Zones and Governmental Appointees of the same positions if he has been released from the office, shall get free medical services for himself and his family in local public health institutions or, where appropriate, in private health institutions at the expense of the government
 - 3) Vice Head of Bureaus, Vice Administrators of Zones and Governmental Appointees of the same positions *if he has been released from the office*, shall get free medical services for himself and his family in local public health institutions.

II. Security Services

- 1) If a President and Vice President are provided with security protection while in service, he shall be entitled to the same service for himself and his family after he has been released from office.
- 2) The composition and size of security force shall be determined by the body in charge of the security service.

12. Certificate of Service

- 1) President, Vice President, Head and Vice Head of Bureau, Administrators and Vice Administrator of Zone, and Governmental Appointees of same positions:
- (a) a certificate service of 1st level rank if he has served for two or more election terms;
 - (b) a certificate service of 2nd level rank if he has served for more than one and less than two election terms;
 - (c) a certificate service of 3rd level rank if he has served for one full election term;
 - (d) a certificate service of 4th level rank if he has served for more than one and less than one election term.
- 2) A certificate of service to be issued to a President and Vice President shall be issued by the Speaker of the Caffee Oromia, and that to be issued to Head and Vice Head of Bureau, Administrator and Vice Administrator of Zone, and Governmental Appointees of the same positions shall be signed by the President of the Region.
- 3) A Regional Government Appointees issued with a certificate of service shall be entitled to:
- (a) preference in getting medical services in public hospitals;
 - (b) A seat of honor at a place where a public ceremony is held.

- 4) A President and Vice President issued with a certificate of service of 1st rank shall in addition to the benefits provided for under Sub-Article 3 of this Article, be entitled to:
- (a) diplomatic passport;
 - (b) VIP services at airport;
 - (c) Government funding of 50% of his air fare for his local flight.
- 5) A President and Vice President issued with a certificate of service of 2nd rank and Head of Bureau, Administrator of Zone, and Governmental Appointees of the same positions 1st rank shall in addition to the benefits provided for under Sub-Article 3 of this Article in consultation with concerned body, be entitled to:
- (a) Diplomatic passport;
 - (b) VIP services at airport;
 - (c) Government funding of 25% of his air fare for his local flight.
- 6) A President and Vice President issued with a certificate of service of 3rd rank or Head of Bureau, Administrator of Zone, and Governmental Appointees of same the positions issued with a certificate of service of 2nd or Deputy Head of Bureau, Deputy Administrator of Zone, and Governmental Appointees of same the positions issued with a certificate of service of 1st rank shall in addition to the benefits provided for under Sub-Article 3 of this Article in consultation with concerned body, be entitled to:
- (a) Diplomatic passport;
 - (b) VIP services at airport;
 - (c) Government funding of 10% of his air fare for his local flight.
- 7) An Ex-President and Vice President issued with a certificate of service of 4th rank or Head of Bureau, Administrator of Zone, and Governmental Appointees of the same positions issued with a certificate of service of 3rd or Vice Head of Bureau, Vice Administrator of Zone, and Governmental Appointees of the same positions issued with a certificate of service of 2nd rank shall in addition to the benefits provided for under Sub-Article 3 of this Article in consultation with concerned body, be entitled to:
- (a) diplomatic passport;
 - (b) VIP services at airport
- 8) Head of Bureau, Administrator of Zone, and Governmental Appointees of the same positions issued with a certificate of service of 4th or Deputy Head of Bureau, Deputy Administrator of Zone, and Governmental Appointees of the same positions issued with a certificate of service of 3rd rank shall in addition to the benefits provided for under Sub-Article 3 of this Article in consultation with concerned body, be entitled to passport service.
- 9) Deputy Head of Bureau, Vice Administrator of Zone, and Governmental Appointees of same positions issued with a certificate of service of 4th shall in addition to the rights and benefits provide for under Sub-Article 3 of this Article.

13. Death of Beneficiary

- 1) If a President, Vice President, Head and Vice Head of Bureau, Administrator and Deputy Administrator of Zone, and Governmental Appointees of the same positions die while in service:
 - (a) His three month's salary shall be paid to his family to cover expenses related to his death
 - (b) The resettlement allowance, severance pay, housing allowance and vehicle allowance that might have been due to him had he been released from office shall be paid to his family.
- 2) If an Ex-President, Vice President, Head and Vice Head of Bureau, Administrator and Vice Administrator of Zone, and Governmental Appointees of the same positions dies before he has received his benefits, the resettlement allowance, severance pay, housing allowance and vehicle allowance that have been due to him shall be paid to his family.
- 3) If a President and Vice President, while in service or after being released from office, dies:
 - (a) The news of his death, together with his short biography, shall be disclosed through government media;
 - (b) a senior government Appointees shall attend his funeral ceremony and lay funeral wreath;
 - (c) The funeral ceremony shall be conducted at the expense of the government.

- 4) The death of a President, Vice President, Head and Vice Head of Bureau, and Governmental Appointees, Administrator and Vice Administrator of Zone, and Governmental Appointees shall not have the effect of terminating the medical benefit offered to his family at local health institutions pursuant to this Proclamation.

SECTION THREE

Rights and Benefits of Regional Ex-Legislative

14. Pension Rights

- 1) The provision of Article 5 of this Proclamation provided for pension right to the Speaker's, and Deputy Speaker's of Caffee Oromia and, Chairman of Standing Committee of Caffee Oromia, Head of the Secretariat Office of the Caffee and shall be applicable to any Governmental Appointees of the same positions.
- 2) The pension rights shall be applicable pursuant to the relevant Pension Law.

15. Maintenance Allowance

- 1) The provision of Article 6 of this Proclamation providing for maintenance allowance shall be applicable to the Speaker and Deputy Speaker of Caffee Oromia, Chairman of Standing Committees of Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions.
- 2) A member of Caffee Oromia who completed one election term and released from office shall be paid one month's salary of Vice Speaker of the coffee in the form of maintenance allowance.

- 3) A member of Caffee Oromia who completed one election term shall be paid an addition of one forth (1/4) of his salary for every additional year of service beyond the first election term.

16. Severance Pay

The provision of article 7 of this Proclamation providing for severance pay shall be applicable to the Speaker, and Deputy Speaker of Caffee Oromia and, Chairman of Standing Committee of Caffee Oromia, and Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions.

17. Housing Allowance

- 1) The provision of Article 8 Sub-Article 2 (a) of this Proclamation providing for housing allowance pay shall also be applicable to the Speaker and Deputy Speaker of Caffee Oromia.
- 2) The provision of Article 8 Sub-Article 2 (c) of this Proclamation providing for housing allowance pay shall also be applicable to the Chairman of Standing Committee of Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions.

18. Vehicle Allowance

- 1) The provision of Article 9 Sub-Article 2 (a) of this Proclamation providing for vehicle allowance pay shall also be applicable to the Speaker and Deputy Speaker of Caffee Oromia.

- 2) The provision of Article 9 Sub-Article 2 (c) of this Proclamation providing for vehicle allowance pay shall also be applicable to the Chairman of Standing Committee of Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions.

19. Medical Benefits

- 1) The provision of Article 10 Sub-Article 1 of this Proclamation providing for medical benefits pay shall also be applicable to the Speaker and Deputy Speaker of the Caffee Oromia.
- 2) The provision of Article 10 Sub-Article 3 of this Proclamation providing for medical benefits pay shall also be applicable to the Chairman of Standing Committee of Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions.

20. Security Services

If the Speaker and Deputy Speaker of the Caffee Oromia is provided with security protection while in service *shall be entitled to the same pursuant to the provision of Article 11 of this Proclamation after s/he has been released from office.*

21. Transport and Luggage Allowance

- 1) A Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of Caffee Oromia shall be entitled to transport and luggage allowance for himself and his family, at the rate of the current transport tariff, when he returns to the place of his permanent residence at the end of his term.

- 2) The beneficiary shall use road or rail transport to be entitled to transport and luggage allowance in accordance with Sub-Article 1; however, that he may be use air transport in case of force majeure.
 - 3) The luggage allowance to be paid in accordance with Sub-Article 1 of this Article shall, depending on the type of land transport used, cover the transport cost of 1,000 kilograms of luggage for the Member alone, and 1,500 kilograms of luggage plus 100 kilograms per a child when accompanied by his spouse and children.
 - 4) If the beneficiary uses his own transport vehicle, the fuel cost shall be calculated on the basis of the distance of his destination and shall be covered by the Government.
- 22. *Reinstatement to Former Job***
- 1) A Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions who is released from office and who was an employee of a government office or public enterprise prior to his election shall, upon his request and the consent of the government, be reinstated to his former job or, if it is not vacant, to a similar vacant job.
 - 2) A Speaker and Deputy Speaker of the of Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions who has been released from office could not be reinstated in accordance with sub-article 1 of this Article, he may be assigned to a similar vacant job in any other government office or public enterprise.
- 3) The service rendered by a Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office and Governmental Appointees of the same positions shall be counted in calculating the period of service he renders in the government office or public enterprise he has reinstated.
- 4) The provision of this Sub-Article 1 to 3 shall not be applicable to job positions to be filled by appointment.
- 23. *Certificate of Service***
- 1) A Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office and Governmental Appointees of the same positions shall be issued:
 - (a) a certificate service of 1st level rank if he has served for two or more election terms;
 - (b) a certificate service of 2nd level rank if he has served for more than one and less than two election terms;
 - (c) a certificate service of 3rd level rank if he has served for one full election term;
 - (d) a certificate service of 4th level rank if he has served for more than half and less than one election term.
 - 2) A certificate of service to be issued to the Speaker of the Caffee Oromia shall be signed by the President of the Region.

- 3) A certificate of service to be issued to Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions, and Members of the Caffee Oromia shall be signed by the Speaker.
- 4) The provision of Article 12 Sub-Article 3 to 7 of this Proclamation providing for benefits shall also be applicable to the Speaker and Vice Speaker of the Caffee Oromia issued with a certificate of services.
- 5) The provision of Article 12 Sub-Article 3, 6 & 9 of this Proclamation providing for benefits shall also be applicable to Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions issued with a certificate of services.
- 6) The provision of Article 12 Sub-Article 3 (a) and (b) of this Proclamation providing for benefits shall also be applicable to Members of the Caffee.

24. Death of Beneficiary

- 1) If Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions die while in service:
 - (a) his three month's salary shall be paid to his family to cover expenses related to his death

- (b) the resettlement allowance, severance pay, housing allowance and vehicle allowance that may have been due to him and he has been released from office shall be paid to his family.
- 2) If Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions dies before he has received his benefits, the resettlement allowance, severance pay, housing allowance and vehicle allowance that have been due to him shall be paid to his family.
- 3) If Speaker and Deputy Speaker of the Caffee Oromia, and Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions dies, before he has received his benefits, the resettlement allowance, severance pay, housing allowance and vehicle allowance that have been due to him shall be paid to his family.
- 4) If Speaker and Deputy Speaker of the Caffee Oromia, dies:
 - (a) The news of his death, together with his short biography, shall be disclosed through government media;
 - (b) a senior government Appointees shall attend his funeral ceremony and lay funeral wreath;

- (c) The funeral ceremony shall be conducted at the expense of the government.

PART FOUR RIGHTS AND BENEFITS OF JUDICIARY

25. Pension Rights

A President and Deputy President of Supreme Court shall be entitled to pension rights in accordance with the relevant pension law.

26. Maintenance Allowance

- 1) A President and Deputy President of Supreme Court shall be entitled to maintenance allowance if he has been released from office:

- (a) after serving for not less than five years; or
- (b) due to sickness, disability or any other ground caused by force majeure upon after serving at least two and half years;

- 2) The amount of maintenance allowance to be paid pursuant to Sub-Article 1 of this Article shall be equivalent to three month's salary for the first year of service, and one month's salary shall be added for every additional year of service; provided, however, that the total amount of maintenance allowance shall not exceed 18 month's salary.

27. Severance Pay

- 1) A President and Deputy President of Supreme Court who has been released from the office shall be entitled to severance pay.

- 2) The amount of severance pay to be paid pursuant to Sub-Article 1 of this Article shall be equivalent to three month's salary for the first year of service, and one third (1/3) of the monthly salary shall be added for every additional year of service; provided, however, that the total amount of maintenance allowance shall not exceed one year's salary.

28. Housing Allowance

A President and Deputy President of Supreme Court if he has been released from office:

- 1) after serving for not less than five years, he shall be paid six month's housing allowance; or
- 2) after serving for more than five years, he shall be paid full payment of housing allowance for the initial six month's service and an addition of half (1/2) of the monthly payment
- 3) without prejudice to the provision of Sub-Article 1(a) and (b), after serving for not less than two and a half years, and due to sickness, disability or any other ground cause by force majeure, he shall be entitled to housing allowance; provided, however, that the total amount of maintenance allowance shall not exceed 18 month's salary.

29. Vehicle Allowance

- 1) A President and Deputy President of Supreme Court shall be entitled to payment of vehicle allowance if he has been released from office.
 - a) After serving for not less than five years
 - b) Due to sickness disability or any other ground caused by force majeure after serving at least two & half years.

2) The vehicle allowance under Sub Article 1 of this article shall be paid in a lump sum, in addition of (1/2) half of the monthly payment for every additional year of service beyond five years of service; provided however that the total payment shall not exceed 18 months vehicle allowance.

30. Medical Benefits of Any President & Deputy President of Supreme Court

- 1) Shall get free medical services for him self and his family in public health institutions or where appropriate in a private health institutions at the expense of the government,
- 2) May get oversees medical services at the expense of the government when recommended by a medical board,
- 3) Where a president and vice president and his spouse are admitted to a local public health institutions they shall be entitled to first class in patient services.

31. Security Service

If president & vice president of Supreme Court Judge is provided with security protection while in service he shall be entitled to the same service for him self and his family after he has been released from office. The composition and size of the security force shall be determined by the body in charge of the security service.

32. Certificate of Service

- 1) An Ex-President and Vice president of Supreme Court:
 - (a) A Certificate of service of 1st rank if he has served ten years or above,
 - (b) A certificate of service of 2nd rank if he has served for more than 5 years and less than 10 ten years,
 - (c) A certificate of service of 3rd rank if he has served for 5 years,
 - (d) A certificate of service of 4th rank if he has served for more than two years & six months and less than 5 years,
- 2) A certificate of service to be issued to An Ex-President & Vice President of Supreme Court shall be signed by the Speaker of the Caffee Oromia.
- 3) Beneficiary of an Ex-Judges issued with a certificate of service shall be entitled
 - (a) Preference in getting medical services in public hospitals,
 - (b) A seat of honor at a place where a public ceremony is held.
- 4) An Ex-President and Vice President of Supreme Court issued with a certificate of service of 1st rank shall in addition to the benefits provided for under Sub-Article 3 of this article in consultation with concerned body be entitled to

- (a) Diplomatic passport
- (b) VIP services at airport
- (c) Government funding of 50% his air fare for his local flight.

5) An Ex-President and Vice President of supreme court issued with a certificate service of 2nd rank, Judges of supreme court and President of High Courts of Oromia 1st rank shall in addition to the benefits provided for under Sub-Article 3 of this article in consultation with concerned body, be entitled to:-

- (a) Diplomatic passport
- (b) VIP services at airport
- (c) Government funding of 25% of his air fare for his local flight.

6) President and Vice President of Supreme Court issued with a certificate of service 3rd rank, Judges of Supreme Courts and President of High Courts issued with a certificate of service of 2nd rank with a certificate shall in addition to the benefits provided for under Sub-Article 3 of this article in consultation with concerned body be entitled to:-

- (a) Diplomatic passport
- (b) VIP services at airport
- (c) Government funding of 10% of his air fare for his local flight

7) President and Vice president of Supreme Court issued with a certificate of service of 4th rank, Judges of Supreme Courts and President of High Courts issued with a certificate of service 3rd issued with a certificate shall in addition to the benefits provided for under Sub-Article 3 of this article in consultation with concerned body, be entitled to:

- (a) Diplomatic passport
- (b) VIP services at airport
- (c) Judges of Supreme Courts and President of High Courts issued with a certificate of service of 4th rank shall in addition to the benefits provided for under Sub-Article 3 of this article in consultation with concerned body, be entitled to passport service.

33. Death of Beneficiary

- 1) If president or Vice president of Supreme Court die while in service:
 - (a) His three months salary shall be paid to his family to cover expenses related to this death.
 - (b) The resettlement allowance, severance pay, housing allowance and vehicle allowance that may have been due to him & he has been released from office shall be paid to his family.
- 2) If a President and Vice President of Supreme Court dies before he has Received his benefits the resettlement allowance, severance pay, housing allowance and vehicle allowance that have been due to him shall be paid to his family.

- 3) If a President and Vice President of Supreme Court, while in service or after being released from office, dies:
- The news of his death, together with short biography, shall be disclosed through government media,
 - A Senior government Appointees shall attend his funeral ceremony and lay funeral wreath,
 - The funeral ceremony shall be conducted at the expense of the Government.
- 4) The death of A President & Vice President of Supreme Court shall not have the effect of terminating the medical benefit offered to his family at local health institutions pursuant to this proclamation.

34. Pension Rights

The pension rights of outgoing Judges of Supreme Courts and President of High Courts shall be applicable pursuant to the relevant pension law.

35. Maintenance Allowance:

- Judges of Supreme Courts and President of High Courts:
 - After serving for not less than five years or
 - Due to sickness disability or any other ground cause by force Majeure after serving at least two & half years.
- The amount of maintenance allowance to be paid pursuant to Sub- Article 1 of this article shall be equivalent three months salary for the first year of service of one months salary shall be added for every additional year of service; provided, however, that the total amount of maintenance allowance shall no exceed 18 months salary.

36. Severance Pay

The provision of Article 27 of this proclamation providing for severance pay applicable to Ex-Judges of Supreme Courts and President of High Courts shall be applicable to Ex-Judges.

37. Housing Allowance:

- Judges of Supreme Courts and President of High Courts
 - After serving for not less than five years or
 - Due to sickness, disability or any other ground causes by force Majeure after serving at least two and half years.
- The housing allowance under Sub-Article 1 of this article shall be paid in a lump sum and its amount shall be in the case of a Supreme Court Judge & President of High Court three month's full payment for the initial service & in addition of half (1/2) of the monthly payment for every additional year of service beyond five years of service.
- Provided, however that the total payment shall not exceed 18 month's Housing allowance.

38. Vehicle Allowance

- Judges of Supreme Courts and President of High Courts
 - After serving for not less than five years or
 - Due to sickness, disability or any other ground caused by force Majeure after serving at least two and half years.

- 2) The vehicle allowance under sub article 1 of this article paid in a lump sum and its amount shall be in the case of a supreme court judge and president of high court three month's full payment for the initial service and in addition of half(1/2) of the monthly payment for every additional year of service beyond five years of service.
- 3) Provided, however, that the total payment shall not exceed 18 months vehicle allowance.

39. Medical Benefits

Judges of Supreme Courts and President of High Courts shall get free medical services for him self's and his family in public health institutions or where appropriate, in private health institutions at the expense of the government.

40. Certificate of Service

- 1) An Ex- Judge of Supreme Court and President of High Court.
 - (a) A certificate of service of 1st rank if he has served for ten years or above,
 - (b) A certificate of service of 2nd rank if he has served for more than 5 less than 10 years,
 - (c) A certificate of service of 3rd rank if he has served for 5 years,
 - (d) A certificate of service of 4th rank if he has served for two years and half up to five years;

- 2) A certificate of service to be issued to Judges of Supreme Court and President of High Courts shall be signed by the Supreme Court President of the Region.

41. Death of Beneficiary

- 1) If judges of supreme and president of high court die while in service:
 - (a) His three months salary shall be paid to his family to cover expenses related to his death.
 - (b) The resettlement allowance, severance pay, housing allowance and vehicle allowance that may have been due to him and he been released from office shall be paid to his family.
- 2) The death of a supreme Court Judge and the President of High Court shall not have the effect of terminating the medical benefit offered to his family at local health institutions pursuant to this proclamation

PART FIVE

Miscellaneous Provisions

42. Rate of Housing and Vehicle Allowances

- 1) The rate of housing allowance to be paid pursuant to this proclamation shall be determined by directives of the Administrative Council of the Regional Government issued in consideration of the current rates of house rent.
- 2) The rate of vehicle allowances to be paid pursuant to this proclamation shall be determined by the directives of the Administrative Council of the Regional Government issued in consideration of the current costs of fuel, grease, oil maintenance and other running cost of vehicles.

43. Computation of Service and Relations of Benefits

- 1) The service of President, Vice President, Heads and Vice Heads of Bureaus, Governmental Appointees of the same positions, Administrators and Vice Administrators of zones, the Speaker & Vice Speaker of the Caffee Oromia, Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions prior to his appointment shall be considered in computing his service pursuant to this proclamation.
- 2) The service of the Speaker & Vice Speaker of Caffee, Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions prior to his election shall be considered in computing his service pursuant to this proclamation.
- 3) The service of President, Vice President, Heads and Vice Heads of Bureaus, Governmental Appointees of the same positions, Administrators & Vice Administrators of zones, the Speaker and Vice Speaker of the Caffee Oromia Chairman of Standing Committee of the Caffee Oromia, Head of the Secretariat Office of the Caffee and Governmental Appointees of the same positions prior to his appointment or election in federal higher Appointees or in federation council or in representative of house of people's council shall be considered in computing his service pursuant to this proclamation.

- 4) Any previous service referred to in Sub-Article 1, 2 or 3 of this article shall not be considered in computing service pursuant to this proclamation if the beneficiary has already acquired rights and benefits relating to the said service in accordance with this proclamation.
- 5) Where the previous service referred to in Sub-Article 1, 2 or 3 of this article entitles the beneficiary with better rights and benefits, such rights and benefits shall be applicable.
- 6) Where a beneficiary was a member of Caffee and government Appointees at the same time, he shall be entitled to the rights and benefits of a member of Caffee, and Government Appointees, which ever is higher.
- 7) Where any Government Appointees has served at different levels of Government Appointees position, he shall be entitled to the rights and benefits applicable, in accordance with this proclamation, to the highest position he assumed at any time of his tenure.

44. Deprivation of Rights and Benefits

- 1) Any president, Vice president, Heads and Vice Heads of Bureaus, Governmental Appointees of the same positions and Administrators and Vice Administrators of zones shall not be entitled to the rights and benefits under this proclamation if he is removed from office:-
 - (a) Failed to implement or cause the implementation of government policies.
 - (b) Abused his power
 - (c) In valued in corrupt practices
 - (d) Given or disclosed confidential information to a party not entitled to.

- 2) Any Speaker and Vice Speaker of the Caffee Oromia, Chairman of Standing Committee of the Caffee Oromia, and Member of the Caffee Oromia shall not be entitled to the rights and benefits under this proclamation if he is removed from office:
 - (a) For having no confidence of the electorate; or
 - (b) Due to misconduct
- 3) Any beneficiary accordance under Sub-Article 1 and 2 shall not be entitled to the rights and benefits under this proclamation if he has resigned without following the prescribed procedure.

45. Termination of Rights and Benefits

- 1) The enjoyment of rights and benefits under this proclamation shall be terminated where:
 - (a) Attempts to disrupt the constitutional order
 - (b) Involves in any act endangering the sovereignty of the country;
 - (c) Commits an act of treason
 - (d) Fails to keep the confidentiality of securable information related to the affairs of the nation and region known to him during his office responsibility.
 - (e) Fails to respect the bodies constituted under Federal and Regional constitutions.
 - (f) Any judge engages in rendering advocacy services after leaving his/her position;

- 2) (g) Any government Appointees is employed within two years from the date of his release, by any private organization or international organization other than inter governmental organization or by non governmental organization that has direct relationship with the government office he was in charge of,
- 2) The termination of rights and benefits pursuant to Sub-Article 1 (a) & (e) of this article shall be effected upon the decision of the region council following the conviction of the beneficiary by the competent court.
- 3) The termination of rights and benefits pursuant Sub-Article 1 (f) and (g) of this article shall be effected upon the decision of region council following the investigation conducted by the Region Ethics and Anti-Corruption Commission on the offense committed by the beneficiary.
- 4) A beneficiary shall notify the appropriate body total or partial waiver of his rights and benefits under this proclamation if he wishes so.

46. Organs Responsible to Execute the Proclamation

- 1) The Office of the President of Oromia Regional Government for Public Officials and Appointees of Executive Organs who have been released from office
- 2) The Members of Caffee Oromia, Head of the Secretariat Office of the Caffee, Public Officials and Appointees of Executive Organs who have been released from office
- 3) The Oromia Supreme Court for Public Officials, and Appointees of Judiciary organs who have been released from office

4) Oromia Capacity Building Bureau, Oromia Finance and Economic Development Bureau and Oromia Civil Service Commission handle complains and appeals of beneficiaries on the implementation of the Rights and Benefits.

47. Power to Issue Regulations and Directives

The Administrative Council of the Regional Government may issue Regulations and Directives necessary for the implementation of this proclamation.

48. Non-applicability

No laws, Regulation, Directives, and practices inconsistent with this proclamation have force or effect in respect of matters provided for in this proclamation.

49. Effective Date

This proclamation shall enter into force as of the July 7th, 2010.

46. Drama Capacity Building Division, Drama Planning and Economic Development Bureau and Drama and Cultural Services Commission handle complaints and appeals of beneficiaries on the implementation of the Rights and Benefits.

47. Power to Issue Regulations and Directives

The Administrative Council of the Registration Committee may issue Regulations and Directives necessary for the implementation of the Rights and Benefits.

Type of Content

48. Not laws, Regulations, Directives, and other documents issued by the Government of the Philippines in accordance with its powers and functions, or any instrument or document provided for in this proclamation.

49. Effective Date

This proclamation shall take effect on the day of the publication of this in the *Philippine Daily Herald* and *Malaya*.
