BUDGET PROCLAMATION FOR ORROMIYA REGIONAL STATE SERVICES

WHEREAS, it is necessary to adopt and implement the budgetary to adopt and implement the budgetary appropriation which are required for the purposes and services of Oromia Regional State for the 1994 (E.C) fiscal year.

WHEREAS, the Regional State is vested under the Constitution of the Federal Democratic Republic of Ethiopia with the power to adopt and implement its own annual budget.

NOW, THEREFORE, in Accordance with Article 49(3)(a) of the Constitution of the Oromia Regional State, it is hereby Proclaimed as follows:

Part One
General
Short Title

Article 1: This Proclamation may be cited as the 1994 E.C Fiscal Year Oromia Regional State Additional Budget Proclamation No. 58/2002

Article 2: Budget Year and Amount of Budget Regional Budget is hereby appointed for the fiscal year commencing to Tir 1, 1994 (E.C.) and ending on Sene 30, 1994 (E.C.) from public revenues and other funds for the purposes and services set forth in the schedule hereto

- (a) For Recurent Expenditure Birr 110,000,000
- (b) For Capital Expenditure . Birr
- (c) Subsidies for Woreda 'Aana' in total Birr 110,000,000 (The details are attached to this Proclamation).

PART TWO

Budget Administration

Article 3: Budget transfer

Budgetary transfer shall be effected in accordance with Articles 17, 18, 19 & 20 of Financial Administration Proclamation No. 17/1997 & Article 17 of Financial Administration Regulations No. 8/1997.

Article 4: Budget Execution

- 1 The Head of the Oromia Finance and Economic Development Bureau is hereby authorized, upon the request of the heads the concerned Oromia Regional State Organs, to disburse out of the public revenue of the Region and other fund the amounts appropriated for the programs of their respective departments.
- 2 The Head of the Oromia Finance and Economic Development Bureau is hereby authorized to grant permission to the Oromia Regional State Hospitals to retain and expend within their total budgetary appropriation of the current fiscal year an amount exceeding 50% (fifty percent) of their previous fiscal year receipts.
