**PROCLAMATION NO. 78/2004
A PROCLAMATION TO PROVIDE
FOR THE ESTABLISHMENT
OF URBAN WATER SUPPLY
AND SEWERAGE SERVICE
ENTERPRISE OF THE OROMIA
REGIONAL STATE**

WHEREAS, The Regional State of Oromia is making a great effort to cover the region with clean, sufficient and sustainable potable water;

WHEREAS, it is found necessary to give proper attention to urban dwellers to free them from shortage of potable water and to give them adequate potable water and sewerage services:

WHEREAS, it is found necessary to reorganize independently the offices and management of Urban Water Supply Services in such a way that they assist the implementation of Water Resource policy and Urban Development and Industry Strategy of the government and that they provide better water supply and sewerage services to the community;

NOW, THEREFORE, in accordance with Article 49 (3) (a) of the Regional State of Oromia, it is here by proclaimed as follow:-

- 9) "Sarara dhangala'aa" jechuun sararoota dhangala'aan walqabatan akkasumas maan hooliiwwan saraaraa dhangala'aa irraatti argaman kan dabalatuu dha.

10) "Tajaajila dhangala'aa maqsuu" jechuun bishaan xuraawaa yookiin dhangala'aa walitti qabuu, qulqulleessuu fi dhabamsis-suu dha.

11) "Dhangala'aa bishaan xuraa'ee" jechuun bishaan qulqulluu tajaajila mana keessa, daldala, industrii, mana qopheessaaf, yookiin tajaajila hawwaasummaaf erga oolee booda sadarkaa kamiiniyyuu haa ta'uu kan xura'ee dhangala'uudha.

12) "Hojiiwwan dhangala'aa" jechuun hojiiwwan, saraarootaafi meeshawwan qulquleessaa dhangala'aa hunda kan ilaaluudha.

13) "Magaalaa" jechuun qaamni seeraan aangoon kennameef "magaalaa" jechuudhaan kan galmeesseedha.

- 9) "Sewer line" shall mean a series of sewers including the manholes, if any, along the sewer.
 - 10) "Sewerage Service" shall mean the collection, treatment and disposal of waste water/sewerage.
 - 11) "Waste water/Sewage" shall mean a water polluted to a certain after we use treated water for domestic, commercial, industrial, municipal or social use
 - 12) "Waste Water Works" shall mean sewer lines and all structures and appliances in the wastewater treatment plant.
 - 13) "Urban" shall mean a town designated as so by an organ, which has a legal personality.

3. Establishment

Any enterprise shall be established on the basis of a regulation to be issued pursuant to this proclamation.

4. Objectives

The Enterprise to be established on the basis of a regulation to be issued shall have the following objectives:-

- 1) Provides adequate potable water supply and sewerage services to dwellers in and around a specific town.
 - 2) Administers itself on the basis of cost coverage principle and the decision and guidelines of a board that could be established to lead and regulate the enterprise.
 - 3.) Establishes a system that assists to boost the effort being made to provide water supply and sewerage services including waste disposal in its work areas.

PART 2

Organization, Powers and Purposes of the Enterprise

5. Power and Duties of the Enterprise

The enterprise shall have the following power and duties:

 - 1) It shall provide potable and adequate water supply to the dwellers in and around the town; it shall ensure that the water supplied is to the standard of the World Health Organization.

The Board shall be accountable to

supreme body.
- 2) It shall write supporting letters
to banks to enable the enter-
prise open and operate a Bank
Account.
- 3) Without prejudice to the
general duties of the provision
of sub article 1, the board
shall:
- (a) Examine and approve
the annual work program and budget the
enterprise submitted to
it.
- (b) Appraise the service
tariff the enterprise sub-
mitted to it and pass it
over to the concerned
organ for approval.

- 1) Follow up that the services provided by the enterprise is in accordance with the Water Resources Management Policy and Water Law of the country.
- 2) Create favorable conditions that enable the enterprises get the necessary support from government and non-government organizations in the form of loans, grants and gifts.
- 3) Give any technical and consultancy support.

2) The Board shall study and amend the rates of charges for the services that the enterprise provides as per sub article (1) of this article, and implement same when approvoed by the concerned body.

15. Right to Expropriate

The Enterprise is entitled to expropriate and acquire immovable property by way of expropriation by paying fair compensation in respect there of, according to the relevant law, where the use of such property is required for the achievement of the enterprise's objective.

16. Prohibition

1) No person shall extend, make use of and transfer the distribution lines of water supplies and sewerage systems of the enterprise for personal use with or without payment.

2) No person shall construct any work within the range of one meter to the right and left of the already installed water and sewerage lines.

3) Any Client of the Etnerprise who owned a water meter shall not divert and use or make others use water prior to passing through the water meter

17. Right to Undertake Water Development Works on Possession of Others

1) The Enterprise may upon payment of fair compensation to a damage it causes on the property of others can lay distribution lines across any person's property and undertake any other water related development activities if deemed necessary.

2) No body can damage the water lines passed through his property or his possession and shall not prohibit the effort the enterprise makes to lay, make use of, supervise, care or maintain water works.

18. Right to Lay Pipe Lines on Roads and Streets

The enterprise is here by entitled to lay, repair or replace any water or sewer line across roads and streets, including cutting or digging if deemed necessary under the following conditions.

- (a) Except in case of emergency, it shall give three (3) months prior written notice of its intention to the concerned authority and get consent before commencing the works. Nevertheless, if the concerned authority or the owner of the road fails to give feed back within specific time, it shall be taken for granted that the permit is secured and the enterprise shall proceed with the works.
- (b) The Enterprise shall have the duty to cover the cost of reinstatement of the road or street.

19. Obligation of the Enterprise

- 1) The Enterprise shall be liable for damage it causes to its customers or third parties through negligence. However, the enterprise may not be liable for damage resulted, where such damage caused is beyond the control or out of the knowledge of the enterprise or due to technical reasons.

21. Fiscal Year

The fiscal year of the Enterprise starts on July 8, ends on July 7 of the next year.

22. Books of Accounts

- 1) The Enterprise shall keep accurate and monetary related books of accounts.
- 2) Auditors selected by the Board shall audit the Enterprise's books of accounts at least once a year; as it may necessary the books of accounts could be audited at any time.

23. Power to Issue Regulation

- 1) The Regional Government may issue regulation for the implementation of this proclamation.
- 2) The Bureau may issue necessary directive.

24. Administrative Procedure of the Civil Servant

The administrative procedure of the civil servant and finance shall be decided by the regulation.

25. Enabling Satellite Water Services Administer Themselves

- 1) Before the establishment of Water Supply and Sewerage Service Enterprise, the former service with satellite under it ceases to have satellite water supply service. The enterprise shall no more have satellite water supply service under it in the future.
