**PROCLAMATION NO. 79/2004
A PROCLAMATION TO AMEND
THE OROMIA CIVIL SERVANTS
PROCLAMATION**

WHEREAS, it has become necessary to have effective and well disciplined man power to perform the on going Civil Service Reform Program of the Region efficiently.

WHEREAS, it is appropriate to make him understand correctly the Regional Governmental policies, strategies and programs and provide his personal career and work motivation to eradicate the existing poverty and under development.

NOW THEREFORE, in accordance with Art 49(3) (a) of the amended Constitution of the Region it is hereby proclaimed as follows;

1. Short Title

This proclamation may be cited as the
“Oromia Regional State Civil Servant
Proclamation Amendment Proclama-
tion No. 79/2004”

- ## **2. Amendment**

The Oromia Regional State Civil Servants Proclamation No. 61/2002 is amended by this Proclamation as follows;

Next to part 11 of the Proclamation a new part 12 is added, and the previous part 12 is hereby changed to part 13, and Articles found begining from Art. 88 are set based on these additional classes and newly entered Articles shifted to Art. 93, 94, 95 and 96.

PART 12

THE PERFORMANCE AND EXECUTION PRINCIPLES

of the Special Disciplinary Procedure.

88. The objective of the Special Disciplinary Measures

The objective of the Special Disciplinary Measures is to screen out those workers who are not efficient and can't play a constructive role in the on going Civil Service Reform Program of the Region from those of hard working and to clarify the man power of the Civil Service.

89. The Special Disciplinary Regulation

- 1) To implement the Civil Service Reform Program in the Region, through evaluating the previous working process and condition of the Civil Service and to create efficient and well disciplined Governmental Civil Servant Administration and System of working with in the Region, the Council of the Region shall issue Regulation for the execution of the Special Disciplinary Measures.

- 2) Without prejudice to the provisions of the relevant pension law, those Civil Servants who fall under the Regulation issued by the Council of the Regional Government to put in effect the Special Disciplinary Measures, the Regional Civil Service Proclamation of part 9 and 11 are not applicable.

90. *Obligation of the Governmental Offices*

- 1) Every Governmental Office so as to create a possible condition to implement the Regional Governmental strategies, and programs shall form a committee under them who analyze and screen out workers based on Efficiency of work, motivation, discipline and present his findings to the Head of the Office.

(d) Dhaabbilee siyaasaa farra nageenyaa fi seeraan alaa keessatti hirmaanaa kan hin qabne ta'uu;

(e) Jijiirama gurma'iinaa fi hojjimaata bulchiinsa naan-nichaa kan fudhatanii fi raawwii isaatiifs qophaa'a ta'anii argamuu.

3) Korichi maqaa hojjettoota ulaagaalee Keewwata kana keewwata xiqqaa (2) jalatti ib-saman guutuudhaan ramaddiidhaaf gahaa ta'anii argaman ittigaafatamaa ol-aanaa mana hojichaatiif dhiheessa.

4) Bu'aan hojji korichaa it-tigaafatamaa mana hojichaatiin erga ilaalamee booda walga'ii waliigalaa hojjattoota mana hojichaatiif dhihaatee irratti mari'atama.

5) Maqaan hojjettoota Mootummaa ulaagaalee hin guutnee fi ramaddiidhaaf hin geenye, akka barbaachisummaa isaatti, karaa it-tigaafatamaa olaanaa mana hojichaatiin Manneetti Maree Bulchiinsa Naannoo, Godinaa yookiin Aanaatiif sababa gahaa ta'e waliin dhihaatee murteen itti kennama.

6) Ramaddii dhoowatamuudhaan murtee kennamerratti hojjetaan komii qabu kamiyyuu mana maree bulchiinsaa sadarkaan itti aanee argamutti ol iyyachuu ni danda'a Murteenmanni marichaatiif oliyyaticha dhaggeeffachuu kennusisa dhumaat a'.

7) In any circumstance the decision of the Council of the Regional Government is final and appeal can't be asked on or is not allowed. (a)

91. Specification of the Special disciplinary Measure Execution Principle

1) Based on evaluation made by the committee formed in the Governmental Office of Civil Servant who is to be found and proved familiar with one or another of the following mentioned problems, will be fired by these Proclamations and by the Regulations which will be issued to ~~call~~ execute the proclamation.

(a) He who is highly corrupted or incautious manner paved the way for robbery the resource and property of the government and the people and keep it for his personal prosperity or for the others or made it to be lost or unnecessary wastage due to clear inefficiency and luck of supervision.

(b) He who acts as a member and supporter of anti peace organization, perform his duty for these political mission.

(c) He who is found and proved to stumble intentionally the issued policies, strategies of the government that realize the process of change started.

(d) When clear disciplinary problem is seen on.

(e) He who retreats the responsibility of work given to him by giving unnecessary reasons, or has no work feeling and has encourage problem.

(f) When his work performance is evaluated in general manifest inefficiency or luck of potential or the problem is seen from.

(g) He who performs his duty based on fellowship, college in partiality and who do not treat the customer equality

(h) Gahumsaafi dandeettii isaa yookiin ishee malee kan ramadame yookiin kan ramade yoo ta'e;

(h) He who is assigned with out his efficiency and potential or who assigned the others.

2) The name of Civil Servants who are to be fired pursuant to manifestation of the above mentioned problem will be presented with full reason by the Head of the Office to the Council of the Regional Government or Zonal and Wereda Administration Council and gets decision.

3) Any Civil Servant who has complain over the firing decision of the Council has a right to appeal to the Administration Council found in the next stage. The decision of the Administrative Council that hear the appeal is final.

4) In any circumstance the decision given by the Regional Governmental council is final and appeal is not allowed.

5) In accordance to this Proclamation, at any stage the decision of firing a civil Servant can be executed only when it is approved by the Council of the Regional Government.

92. The Endurance of the Special Disciplinary Measure

1) On the process of re-organizing the Civil Servants by the Council of the Regional Government the conditions of the specification of the Special Disciplinary Measures to be implemented is desided based on the Regulation issued by the Council of the Regional Government, and then endurance of this Special Disciplinary Measures would be only for one year.
