Proclamation No. 180/2013

A Proclamation to Establish Irrigation De-
velopment Authority of Oromia National
Regional State

WHEREAS, it is found necessary to ex-
pand irrigation development to secure food
self sufficiency and increase production
and productivity to supply raw materials
for industries without being dependent on
erratic and uneven rainfall distribution;

WHEREAS, it is found necessary to bring
together different irrigation development
activities which were under taken and fol-
lowed by different bodies, which weak-
ened the development activity and bring
together the scattered resource to one
place and use it;

WHEREAS, it is found necessary to es-
tablish an independent governmental or-
gan to expand irrigation development in a
sustainable manner without affecting the
environment;

1. Mataduree Gabaabaa

- 5) **“Jallisii Ammayyaa”** jechuun bu'uraawwan jallisii haala ammayyaatiin ijaaramanii teekinoolojii ammayyaa irratti diriire fayyadamuun oomisha qonnaa jallisii gaggeessuu jechuudha.
- 6) **“Jallisii Bonee”** jechuun misooma qonna jallisii jiidhina lafa keessa jiruun fayyadamuun kan misoomu jechuudha.
- 7) **“Jallisii Maayikiroo”** jechuun jallisii lafa hektaara 2.5 gadi ta'e irratti gaggeeffamu jechuudha.
- 8) **“Jallisii Xixiqqaa”** jechuun jallisii lafa hektaara 2.5 hanga hektaara 200 ta'e irratti gaggeeffamu jechuudha.
- 9) **“Jallisii Giddugaleessa”** jechuun jallisii ammayyaa lafa bal'ina hektaara 200 olii hanga lafa hektaara 3000 kan ta'e jechuudha.

- ፩) **“የአዉታር አስተዳደር”** ማለት በተለያዩ ደረጃ ግንባታቸው የተጠናቀቁ እና የመስኖ አዉታሮችን እንዲጠበቁ ማድረግ፣ መከታተል፣ መንከባከብና በማስተዳደር ቀጣይነት ያለው የመስኖ አገልግሎት እንዲሰጥ ማድረግ ማለት ነው፡፡

NOW THEREFORE, in accordance with Article 49 Sub-Article 3(a) of Proclamation No. 46/2001 of the Revised Constitution of the National Regional State of Oromia, it is hereby proclaimed as follows:

PART ONE

General Provisions

1. Short Title

This proclamation may be cited as “Irrigation Development Authority Establishment Proclamation No. 180/2013”.

2. Definition

Unless the context requires otherwise, in this proclamation:

- 1) **“Scheme Administration”** means to manage, follow up, care, and administer different irrigation scale which their construction is completed to make them able to give sustainable irrigation supply.
- 2) **“Irrigation Scheme”** means an irrigation field having traditional and modern irrigation infrastructure and development found at a defined place.
- 3) **“Users”** any person, private association or organization or that uses irrigation development scheme.
- 4) **“Traditional Irrigation”** means developing irrigation farming using traditional method, skill and local material.
- 5) **“Modern Irrigation”** means developing irrigation farming using irrigation infrastructures constructed in modern way having modern technology.
- 6) **“Jallisii Bonne/Moisture Irrigation/”** means developing irrigation farming using soil moisture.
- 7) **“Micro Irrigation”** means an irrigation undertaken on an area of less than 2.5 hectares.
- 8) **“Small Scale Irrigation”** means an irrigation undertaken on an area of 2.5 - 200 hectares.
- 9) **“Medium Scale Irrigation”** means an irrigation which undertaken on an area of above 200 to 3000 hectares.

- 10) “Jallisii Gurguddaa” jechuun jallisii ammayyaa lafa hektaara 3000 ol ta’e irratti gaggeeffamu jechuudha.
- 11) “Misooma Jallisii” jechuun bishaan lafa irraa yookiin bishaan lafa jallaa yookiin lachuun teekinooloojiiwan adda addaa fayyadamuudhaan misooma qonnaa jallisii misoomu babal’isuu jechuudha.
- 12) “Qonna Jallisii” jechuun bishaan jallisii fayyadamuudhaan misooma qonnaa gaggeeffamu jechuudha.
- 13) “Qoorsa lafaa” jechuun bishaan biqiltuun barbaaduun ol ta’e ooyiruu keessaa baasuu jechuudha.
- 14) “Teekinooloojii” jechuun bu’uuraalee fi galteewwan misooma jallisii babal’isuu danda’an hunda jechuudha.

3. Ibsa Koorniyaa

Labsii kana keessatti koorniyaa dhiiraatiin kan ibsame dubartiis ni dabalata.

4. Hundeeffamaa fi Itti Waamama

- 1) Abbaan Taayitaa Misooma Jallisii Mootummaa Naannoo Oromiyaa kanaan booda “Abbaa Taayitaa” jedhamee kan waamamu Labsii kanaan hundeeffamee jira.
- 2) Itti waamamni Abbaa Taayitichaa Pireezidaantii Mootummaa Naannoo Oromiyaatiif ta’a.

5. Kaayyoo

Guddinni hawaasummaafi dinagdee qotee bulaa fi horsiisee bulaa akka ariifatu, hanqinni midhaan nyaataa akka salphatuu fi haala ittifufiinsa qabuun ummanni naannichaa midhaan nyaataatiin akka of danda’u taasisuuf misooma jallisiiitiin deeggaruuf.

6. Teessoo Abbaa Taayitichaa

Teessoon waajjira olaanaa Abbaa Taayitichaa Finfinnee ta’ee akka barbaachisummaa isaatti sadarkaa Godina, Aanaafi Ganda keessatti waajjira banachuu ni danda’a.

- 3) Hojjattoota barbaachisaa ta’an ni qabaata.

፲፬) “ቴክኖሎጂ” ማለት የመስኖ ልማትን ለማስፋፋት የሚያስችሉ መሠረተ ልማቶችና ግብዓቶች ሁሉ ማለት ነው።

፫. የፆታ መግለጫ

በዚህ አዋጅ ውስጥ በወንድ ፆታ የተገለፀው ሴትንም ይጨምራል።

፬. ስለማቋቋም እና ስለተጠሪነት

፩) የኦሮሚያ ብሔራዊ ክልላዊ መንግሥት የመስኖ ልማት ባለስልጣን ከዚህ በኋላ “ባለሥልጣን” ተብሎ የሚጠራ በዚህ አዋጅ ተቋቁሟል።

፪) የባለስልጣኑ ተጠሪነት ለኦሮሚያ ብሔራዊ ክልላዊ መንግሥት ፕሬዝዳንት ይሆናል።

፭. ዓላማ

የክልሉ አርሶ አደር እና አርብቶ አደር ማህበራዊ እና ኢኮኖሚያዊ እድገት እንዲፋጠን፣ የምግብ ሰብል እጥረት እንዲቀንስ እና የክልሉ ህዝብ ቀጣይነት ባለው ሁኔታ የምግብ ሰብል ራሱን እንዲችል በመስኖ ልማት መደገፍ።

፮. የባለሥልጣኑ መቀመጫ

የባለሥልጣኑ የዋና መሥሪያ ቤት መቀመጫ ፊንፊኔ ሆኖ እንደአስፈላጊነቱ በዞን፣ በወረዳና በቀበሌ ጽ/ቤት ሊከፍት ይችላል።

፯. የባለሥልጣኑ አወቃቀር

10) “Large Scale Irrigation” means an irrigation undertaken on an area of more than 3000 hectares.

11) “Irrigation Development” means to develop an irrigation farming using different technologies with ground or surface water or both.

12) “Irrigation Farming” means farming conducted using irrigation water.

13) “Drainage” means to drain excess water from farm land which is more than the need of the crop.

14) “Technology” means all the infrastructures and inputs required for the development of irrigation.

3. Gender Reference

Provisions of this Proclamation set out in a masculine gender shall also apply to the feminine gender.

4. Establishment and Accountability

1) Oromia Irrigation Development Authority, here after referred as “The Authority” is hereby established by this Proclamation.

2) The Authority shall be accountable to the President of the National Regional State of Oromia.

5. Objective

Support by irrigation development, to hasten socio economic growth of the farmers and pastoralist community of the region, to alleviate shortage of food crops and for the people of the region to attain food self-sufficiency in sustainable manner.

6. Office of The Authority

The head office of the Authority shall be in Finfinne and may have offices at Zone, District and Keble level as necessary.

PART TWO

Organization, Powers and Duties of the Authority

7. Organization of The Authority

The Authority shall have:

- 1) General Manager,
- 2) Deputy General Manager and
- 3) Required staffs;

- 4) Bu'a qabeessummaa iskiimoota jallisii guddisuuf fayyadamtoonni hubannoo baasii, kunuunsa, bulchiinsaafi suphaa qabaatanii qarshii akka qusatan ni gorsa; ni hordofa; akkasumas deeggarsa barbaachisaa ni kenna.
- 5) Qabeenya bishaanii naannicha keessatti argaman haala ittifuufinsa qabuun misooma jallisiitiif akka ooluu danda'an qaama dhimmi ilaalu waliin ta'uudhaan kunuunsa isaanii irratti ni hojjata.
- 6) Hojii qoorsa lafa naannicha keessatti iddoo barbaachisaa ta'etti ni hojjata.
- 7) Hojii bishaan cimmisuu misooma jallisiif oolu irratti ni hojjata.
- 8) Qaama dhimmi ilaalu waliin qindaa'uudhaan rakkoolee naannoo misooma jallisiifi qoorsa lafaa, akkasumas teekinolojii jallisii irratti qo'annoo ni gaggeessa; ni qindeessa; bu'aa qo'annoo fi teekinolojiiwwan fooyya'an naannicha keessatti ni babal'isa; iddoo hojjatanii itti agarsiisan ni qopheessa.
- 9) Jallisii maayikiroofi jallisii bonee ummataa akka hojjataman abbummaadhaan ni hordofa; ni deeggara; ni jajjabeessa.
- 10) Qaamota guddinaafi ittifuufinsa misooma jallisiif bu'aa buusuu danda'an waliin ni hojjata.

- ፫) ግንባታቸው የተጠናቀቀ መከላከያና ትላልቅ የመስኖ አውታሮችን ተጠቃሚዎች ራሳቸው ማስተዳደር እስከሚችሉ ድረስ ሙሉ በሙሉ ያስተዳድራል፤ ይከታተላል፤ የቴክኒክ ሥራ ይሰራል፤ ከተጠቃሚዎች አቅም በላይ የሆነ ጥገናን ያከናውናል፤ እንዲከናወን ያደርጋል፤ ተጠቃሚዎች ራሳቸውን ሲችሉ ወደነርሱ ያስተላልፋል፡፡
- ፬) የመስኖ አውታሩን ጠቀሜታ ለማሳደግ ተጠቃሚዎች ስለ ወጪ፣ እንክብካቤ፣ አስተዳደርና ጥገና ግንዛቤ ኖሯቸው ገንዘብ እንዲቆጥቡ ይመክራል፤ ይከታተላል፤ አስፈላጊውንም ድጋፍ ያደርጋል፡፡
- ፭) በክልሉ ውስጥ የሚገኘውን የውሀ ሀብት ቀጣይነት ላለው የመሥሪያ ልማት ሊውል እንዲችል ከሚመለከተው አካል ጋር በመሆን እንክብካቤ ያደርጋል፡፡
- ፮) በክልሉ ውስጥ የመሬት ማንጣፊፍ ሥራ በሚያስፈልግበት ቦታ ላይ ይሰራል፡፡
- ፯) ለመስኖ ልማት የሚውል የውሀ ማቆር ሥራ ይሰራል፡፡

8. Powers and Duties of the Authority

The Authority shall have the following powers and duties:

- 1) Prepares and submit policies, strategies and programs related to irrigation to the government and implement the same upon approval.
- 2) Undertake and cause the undertaking of the study, design, construction and scheme management of traditional, micro, small, medium and large scale irrigation.
- 3) Fully administer, follow up, execute technical work of those medium and large scale irrigations whose construction is completed up until the users are self sufficient to administer; conduct maintenance work and cause to be conducted where it is found to be beyond the capacity of the users, and turn the administration over to them when they are self sufficient.
- 4) Undertake awareness creation advice and follow up on fee collection and saving to increase the effectiveness and efficiency of irrigation scheme.
- 5) Conserve the water resource in the region for sustainable irrigation development in collaboration with the concerned bodies.
- 6) Undertake drainage work where it is necessary in the region.
- 7) Undertake water harvesting for irrigation development.
- 8) Undertake a study with the concerned body on problems related with areas of irrigation development, drainage, also on irrigation technology; coordinate; disseminate research findings and improved technology; prepare demonstration plots.
- 9) Taking the responsibility of following up, supporting, strengthening micro and moisture irrigation to be undertaken by community.
- 10) Collaborate with stakeholders who contribute to the sustainability and growth of irrigation development.

- 33) Own property, enter into contract, sue and be sued.

10. Power and Duties of the Deputy General Manager

- 1) Where in the absence of the General Manager acts on behalf of him;
- 2) Execute works given by the General Manager.

PART THREE

Miscellaneous Provisions

11. Source of Income

The source of income for the Authority is the allocated budget by the government, financial assistance and fees paid for different services.

12. Books of Account

The Authority shall keep complete book of account and financial documents.

13. Audit

The books of account and property of the Authority shall be audited by the Auditor General of Oromia or by an auditor represented by it.

14. Powers to Issue Regulation

The Administrative Council of the National Regional State of Oromia may issue a Regulation to execute this Proclamation.

15. Provision of Transition

- 1) Rights and obligation related to irrigation development which was given to Oromia Water, Mine and Energy and Oromia Agriculture Bureau is transferred to the Authority by this Proclamation;
- 2) Works related to irrigation development which were constructed and those that are under construction by Oromia Water, Mine and Energy and Oromia Agriculture Bureau are transferred to the Authority by this Proclamation.
- 3) Works related to irrigation scheme administration activities which were undertaken by Oromia Water Works Construction Enterprise, assets, data and materials for this work are transferred to the Authority by this Proclamation.
- 4) Assets, data and materials which were used for irrigation development activities at Oromia Agricultural Bureau and Oromia Water Mine and Energy are transferred to the Authority by this Proclamation.

16. Repealed Laws

- 1) Article 17 Sub-Article 13, 20, 21, 22 and 23 of Proclamation No. 163/2011, Executive Organs Proclamation are repealed by this Proclamation;
- 2) Article 24 Sub-Article 2, 3 and 4 of Proclamation No. 163/2011, Executive Organs are repealed by this Proclamation.
- 3) Article 2 Sub-Article 2(b) of Regulation No. 58/2005 issued to amend Regulation No. 14/1999, Regulation to Provide the Amendment of Oromia Water Works Construction Enterprise Establishment is repealed by this Proclamation.
- 4) Any law and practice inconsistent with matters provided for under this Proclamation shall be inapplicable.

17. Effective Date

This Proclamation shall come into force as of the 13th of July 2013.
