NOWTHEREFORE, in accordance with Article 49(3) (a) of the revised Regional constitution proclamation No. 46/2001, it is here by proclaimed as follows.

This Proclamation may be cited
as “Proclamation No.205/2017
Aproclamation enacted to the
Reorganization and Redefini-
tion of the powers and duties
of Executive Organs of Oro-
mia Reginal State Amendment
Proclamation No.199/2017”

2.Amendment

The proclamation No.199/2016
is amended as follows;

1. Article 13 sub article 1(h) is
cancelled and the next Sub ar-
ticle is considered.
2. Following Article 13(5) new
sub Article 6 is added.
Article 13(t) Oromia Police
Commission is accountable to
the Adminstration and securi-
ty Bureau.
3. Article 25(1)has been can-
celled and replaced by the fol-
lowing.
Article 25(1) coordinate, orga-
nize and lead security forces to
ensure peace and stability in
the region.

3. Effective Date

This Proclamation shall come
into force as of the day of its
approval by “Caffee”.
